**Re: Yellow Falls Power Limited Partnership's Application for Leave to Construct a Transmission Line – Request to Reschedule Cost Claim Timeline  
Board File No. EB-2009-0120**

The Board has received your letter dated December 16, 2009 requesting an extension of the deadline for filing the cost claim of the Wabun Tribal Council ("WTC"), citing WTC's staff constraints due to pre-commitments for business meetings and the holiday season.

WTC's requested extension is from December 29, 2009 until Friday January 8, 2010, as set out in the cost claim schedule of the Board's Decision and Order approving the Application, dated December 16, 2009. WTC also asked for a waiver so that the date of delivery of the 2 hard copy of the cost claim to the courier be accepted as received by the Board instead of receipt of these 2 hard copies at the Board's offices.

The Board has agreed to WTC's two requests, as stated above, and therefore find it necessary to reschedule the cost claim steps as follows:

- Wabun Tribal Council and Taykwa Tagamou Nation may file with the Board by **Friday, January 8, 2010** their respective cost claims, subject to the restrictions which have been placed upon their cost eligibility, and in accordance with the Board's Practice Direction on Cost Awards. A copy of each cost claim shall be sent to Yellow Falls Power Limited Partnership.

- Yellow Falls Power Limited Partnership may object to either cost claim no later than **Monday, January 18, 2010**, by filing its submission with the Board and delivering a copy to the intervenor in relation to whose cost claim the objection is made.
- If an objection to an intervenor's cost claim is filed, that intervenor will have until **Thursday, January 28, 2010** to make a reply submission to the Board, with a copy to Yellow Falls Power Limited Partnership as to why its cost claim should be allowed.
