NOTICE OF APPLICATION FOR INTERVENTION

1. IGPC Ethanol Inc. and the Integrated Grain Processors Co-operative Inc. ("IGPC") are the developer of a 150 million liter per year ethanol facility in the Town of Aylmer, and within the Natural Resources Gas Limited ("**NRG**") franchise area.
2. NRG has initiated a process to exempt itself from certain obligations of the GDAR which may impact the level of service NRG customers receive.
3. IGPC seeks full status of an intervenor in this proceeding and reserves its rights to file evidence, cross-examine witnesses, make submissions, and generally fully participate in this proceeding. However, at this time, IGPC plans to monitor the proceeding.


