Dear Ms. Walli,

I have received and read via email the letter from you to Mr. Edward Veldboom granting an extension for filing the Municipality's submission because Plateau Wind Inc failed to serve them with a copy the submission to the Board by November 8, 2010. I have also reviewed Plateau Wind Inc.'s written submission regarding file EB-2010-0253. There are several things that I find disturbing.

On October 29, 2010 the Ontario Energy Board issued a Procedural Order. It states that:

1. Plateau shall file with the Board and serve on Grey Highlands by **Monday, November 8, 2010**, (emphasis yours) a written submission that includes:

- a summary description (including map(s)) of the proposed location of the distribution facilities within the road allowances described in Plateau's application and shown in the map accompanying the Notice of Application;
- rationale for the proposed location and any supporting documentation; and
- description of any alternative location within the road allowances that Plateau considers feasible including comparisons with the proposed location.

Mr. Dyck of Torys LLP states in his cover letter dated November 8, 2010, that "In accordance with the Ontario Energy Board's Procedural Order, please find enclosed Plateau's written submission". I noticed on the OEB website that the submission was received by the board on the 10th of November. Further more Plateau Wind Inc (PWI) did not serve the Municipality of Grey Highlands until the 16th of November. This strikes me as a gross disregard for the Ontario Energy Board's authority in this matter.

Appendix E, Tab 2, page 54 of the submission entitled Grey Highlands Municipal Staff report, is a letter written by me to the Municipal Council dated April 28, 2010. This letter addresses concerns regarding the siting of turbine 5 that had changed locations several times. The only connection to the road use agreement is the fact that the public found out about the relocation of the turbine because it was on the map that PWI submitted to the council in its presentation regarding the road use agreement. This letter also expresses concerns about PWI lack of respect for citizens concerns and participation in the process.

My letter has been posted on the OEB web site unredacted and again supplies my address for the world to access, violating the privacy act. What possible relevancy does this letter have to "establishing the location of Plateau's distribution facilities within certain public

right-of-ways, streets and highways owned by the municipality of Grey Highlands? How can PWI dispute the concerns of citizens because they do not solely address the use of public right-of-ways and then submit this letter in evidence? They cannot have it both ways.

This is once again an example of PWI disregard and disrespect for the people of this community who find themselves in a situation which is life changing and in which we have no say. They claim to be fulfilling their requirements under the Green Energy Act by holding public meetings, but refuse to address the concerns of the citizenry in a public forum. They refuse to respect us as fellow human beings.

PWI does not respect the procedural orders of the OEB. They did not comply with the letter of direction which required PWI to serve a copy of the notice of application to all directly affected landowners. We know this because we canvassed the directly affected landowners, as you are well aware of.

PWI did not have information packages and additional material as they were developed made available for convenient public perusal on their website until the end of October.

PWI disregarded the procedural order to serve the Municipality of Grey Highlands within the time ordered by the OEB. They waited 8 days to so. Again this is disrespectful to the OEB, the Council and the citizens of this community.

PWI has adopted an attitude of arrogance in the process from beginning to end. They have violated all boundaries of civil and procedural decorum.

Please remove my pertinent information from the PWI submission and from the OEB web site.
