**AND IN THE MATTER OF** an application by Brant County  
Power Inc. for an order approving just and reasonable rates  
and other charges for electricity distribution.

### **PROCEDURAL ORDER No. 1**

Brant County Power Inc. ("Brant County" or "the Applicant") filed an application with the Ontario Energy Board (the "Board"), received on November 5, 2010 under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to the rates that Brant County charges for electricity distribution. The Board has assigned the application File Number EB-2009-0125.

The Board issued a Notice of Application and Hearing dated November 26, 2010. The Board has determined that Energy Probe Research Foundation ("Energy Probe"), the Vulnerable Energy Consumer Cooperative ("VECC") and Brantford Power Inc. are eligible for intervenor status and that Energy Probe and the VECC are eligible to apply for an award of costs under the Board's *Practice Direction on Cost Awards*.

The Board has decided to proceed by way an oral hearing and considers it necessary to make provision for the following procedural matters. Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

#### **THE BOARD ORDERS THAT:**

- 1 Board staff and Intervenors who wish information and material from Brant County that is in addition to Brant County's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the

Board and delivered to Brant County on or before **January 10, 2011** for Board staff and **January 14, 2011** for intervenors. If possible, the questions should specifically reference the pre-filed evidence.

- 2 Brant County shall file with the Board complete responses to all interrogatories and deliver them to the intervenors no later than **January 31, 2011**.

All filings to the Board must quote file number EB-2009-0125, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca). If the web portal is not available you may email your document to the [BoardSec@oeb.gov.on.ca](mailto:BoardSec@oeb.gov.on.ca). Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required.
