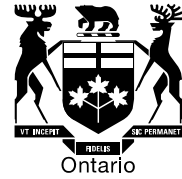

The Ontario Energy Board has now issued its Notice relating to your application for Board approval for your proposed Renewable Natural Gas Program. If publication is impossible within fourteen (14) days, you must inform the Board's case manager immediately.

- To immediately arrange for the enclosed French version of the Notice, headed with the Ontario Government logo and the words "Commission de l'énergie de l'Ontario", to be published in one issue of any French language daily newspaper, if available, and one issue of all weekly French language newspapers throughout Union Gas Limited's service areas;

Note: Please make it clear to the newspaper that any invoices regarding publication are to be sent to the Applicant not to the Board.

- To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all parties involved in Union Gas Limited's 2012 Rates application (EB-2011-0025), set out in Appendix A to this letter;
- To file with the Board, both electronically and hard copy, an affidavit proving publication and, where applicable, service of the Notices immediately thereafter;
- To make a copy of the application and evidence, and any amendments thereto, available for public review at Union Gas Limited's office and on its website, if available; and,
- To provide a copy of the application and evidence, and any amendments thereto, to anyone who requests a copy.
