*Parry Sound's proposed a Lost Revenue Adjustment Mechanism and Shared Savings Mechanism and applied for LRAM and SSM recovery of \$96,367.42 and \$2,399.42 respectively. In support of this proposal, Parry Sound submitted a report prepared by Burman Energy Consultants Group.*

***Board Findings***

*The Board agrees with the submissions of VECC in this instance, and consistent with the Board's findings in the Midland case, will approve the original LRAM recovery as submitted by Parry Sound, updated for OPA 2009 program results. The SSM recovery of \$2,399.42 is also approved.*
