DECISION AND ORDER

Introduction

Middlesex Power Distribution Corporation (“MPDC”), a licensed distributor of electricity, filed its application with the Ontario Energy Board (the “Board”) on November 25, 2011 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that MPDC charges for electricity distribution for the Newbury service area, to be effective May 1, 2012. MPDC filed separate applications for the Main and Dutton service areas.

MPDC is one of 77 electricity distributors in Ontario regulated by the Board. The *Report of the Board on 3rd Generation Incentive Regulation for Ontario’s Electricity Distributors* (the “IR Report”), issued on July 14, 2008, establishes a three year plan term for 3rd generation IRM (i.e., rebasing plus three years). In its October 27, 2010 letter regarding the development of a Renewed Regulatory Framework for Electricity (“RRFE”), the

Board announced that it was extending the IRM plan until such time as the RRFE policy initiatives have been substantially completed. As part of the plan, MPDC is one of the electricity distributors that will have its rates adjusted for 2012 on the basis of the IRM process, which provides for a mechanistic and formulaic adjustment to distribution rates and charges between cost of service applications.

To streamline the process for the approval of distribution rates and charges for distributors, the Board issued its IR Report, its *Supplemental Report of the Board on 3rd Generation Incentive Regulation for Ontario's Electricity Distributors* on September 17, 2008 (the "Supplemental Report"), and its *Addendum to the Supplemental Report of the Board on 3rd Generation Incentive Regulation for Ontario's Electricity Distributors* on January 28, 2009 (collectively the "Reports"). Among other things, the Reports contain the relevant guidelines for 2012 rate adjustments for distributors applying for distribution rate adjustments pursuant to the IRM process. On June 22, 2011, the Board issued an update to Chapter 3 of the Board's *Filing Requirements for Transmission and Distribution Applications* (the "Filing Requirements"), which outlines the application filing requirements for IRM applications based on the policies in the Reports.

On November 16, 2011, MPDC had filed a letter requesting an extension until January 23, 2012 to file the evidence supporting the disposition of Account 1562 – Deferred Payments in Lieu of Taxes ("PILs").

By letter dated November 23, 2011, the Board determined that it would not grant the extension request. The Board noted that until the impacts of disposing of the Account 1562 balances are known, the Board cannot provide proper notice to MPDC's ratepayers of the rate impacts associated with MPDC's 2012 rate application. The Board further noted that in light of MPDC's post-amalgamation circumstances, and in order not to jeopardize a May 1, 2012 implementation date for the other aspects of MPDC's 2012 rate application, the Board directed MPDC to proceed with filing their 2012 rate application excluding the disposition of Account 1562. The Board also directed that MPDC file a stand-alone application by no later than April 1, 2012, for the disposition of Account 1562.

On August 31, 2011, Chatham-Kent Hydro ("CKH") had applied to the Board for leave to amalgamate MPDC with CKH in application EB-2011-0328. On December 16, 2011, the Board approved the amalgamation, and on January 11, 2012 CKH notified the Board that the transaction was complete. On January 20, 2012, CKH received its

amended licence and notification that MPDC's licence had been cancelled. On January 31, 2012, CKH applied to the Board to amend the company name on its licence to "Entegrus Powerlines Inc.". The Board approved this change and issued an updated licence on February 24, 2012. In order to maintain consistency throughout the public record in this proceeding, the Board will continue to use the name MPDC in this Decision and Order.

Notice of MPDC's rate application was given through newspaper publication in MPDC's Dutton service area advising interested parties where the rate application could be viewed and advising how they could intervene in the proceeding or comment on the application. No letters of comment and no letters of intervention were received. Board staff participated in the proceeding. The Board proceeded by way of a written hearing.

While the Board has considered the entire record in this proceeding, it has made reference only to such evidence as is necessary to provide context to its findings. The following issues are addressed in this Decision and Order:

- Price Cap Index Adjustment;
- Rural or Remote Electricity Rate Protection Charge;
- Shared Tax Savings Adjustments;
- Retail Transmission Service Rates;
- Review and Disposition of Group 1 Deferral and Variance Account Balances; and
- Review and Disposition of Account 1521: Special Purpose Charge.

Price Cap Index Adjustment

As outlined in the Reports, distribution rates under the 3rd Generation IRM are to be adjusted by a price escalator, less a productivity factor (X-factor) of 0.72% and a stretch factor.

On March 13, 2012, the Board announced a price escalator of 2.0% for those distributors under IRM that have a rate year commencing May 1, 2012.

The stretch factors are assigned to distributors based on the results of two benchmarking evaluations to divide the Ontario industry into three efficiency cohorts. . In its letter to Licensed Electricity Distributors dated December 1, 2011 the Board assigned MPDC to efficiency cohort 1 and a cohort specific stretch factor of 0.2%.

On that basis, the resulting price cap index adjustment is 1.08%. The price cap index adjustment applies to distribution rates (fixed and variable charges) uniformly across customer classes that are not eligible for Rural or Remote Electricity Rate Protection.

The price cap index adjustment will not apply to the following components of delivery rates:

- Rate Riders;
- Rate Adders;
- Low Voltage Service Charges;
- Retail Transmission Service Rates;
- Wholesale Market Service Rate;
- Rural or Remote Rate Protection Charge;
- Standard Supply Service – Administrative Charge;
- Transformation and Primary Metering Allowances;
- Loss Factors;
- Specific Service Charges;
- MicroFIT Service Charges; and
- Retail Service Charges.

Rural or Remote Electricity Rate Protection Charge

On December 21, 2011, the Board issued a Decision with Reasons and Rate Order (EB-2011-0405) establishing the Rural or Remote Electricity Rate Protection (“RRRP”) benefit and charge for 2012. The Board amended the RRRP charge to be collected by the Independent Electricity System Operator from the current \$0.0013 per kWh to \$0.0011 per kWh effective May 1, 2012. The draft Tariff of Rates and Charges flowing from this Decision and Order will reflect the new RRRP charge.

Shared Tax Savings Adjustments

In its Supplemental Report, the Board determined that a 50/50 sharing of the impact of currently known legislated tax changes, as applied to the tax level reflected in the Board-approved base rates for a distributor, is appropriate.

The calculated annual tax reduction over the IRM plan term will be allocated to

customer rate classes on the basis of the Board-approved base-year distribution revenue. These amounts will be refunded to customers each year of the plan term, over a 12-month period, through a volumetric rate rider using annualized consumption by customer class underlying the Board-approved base rates.

MPDC's application did not include a tax adjustment since the entity was in a tax loss position at the time of the last cost of service application (EB-2009-0177) such that no income tax amount was included in the Board-approved revenue requirement. The Board accepts this proposal.

Retail Transmission Service Rates

Electricity distributors are charged the Ontario Uniform Transmission Rates ("UTRs") at the wholesale level and subsequently pass these charges on to their distribution customers through the Retail Transmission Service Rates ("RTSRs"). Variance accounts are used to capture timing differences and differences in the rate that a distributor pays for wholesale transmission service compared to the retail rate that the distributor is authorized to charge when billing its customers (i.e. variance Accounts 1584 and 1586).

On June 22, 2011 the Board issued revision 3.0 of the *Guideline G-2008-0001 - Electricity Distribution Retail Transmission Service Rates* (the "RTSR Guideline"). The RTSR Guideline outlines the information that the Board requires electricity distributors to file to adjust their RTSRs for 2012. The RTSR Guideline requires electricity distributors to adjust their RTSRs based on a comparison of historical transmission costs adjusted for the new UTR levels and the revenues generated under existing RTSRs. The objective of resetting the rates is to minimize the prospective balances in Accounts 1584 and 1586. In order to assist electricity distributors in the calculation of the distributors' specific RTSRs, Board staff provided a filing module.

On December 20, 2011 the Board issued its Rate Order for Hydro One Transmission (EB-2011-0268) which adjusted the UTRs effective January 1, 2012, as shown in the following table:

The Board finds that these 2012 UTRs are to be incorporated into the filing module.

Review and Disposition of Group 1 Deferral and Variance Account Balances

The *Report of the Board on Electricity Distributors' Deferral and Variance Account Review Report Initiative* (the "EDDVAR Report") provides that, during the IRM plan term, the distributor's Group 1 account balances will be reviewed and disposed if the preset disposition threshold of \$0.001 per kWh (debit or credit) is exceeded. The onus is on the distributor to justify why any account balance in excess of the threshold should not be disposed.

MPDC's 2010 actual year-end total balance for Group 1 Accounts including interest projected to April 30, 2012 is a credit of \$24,823. This amount results in a total credit claim of \$0.0068 per kWh, which exceeds the preset disposition threshold. MPDC proposed to dispose of this credit amount over a one-year period.

In response to Board staff interrogatory #5a, MPDC confirmed that the preset disposition threshold calculation did not include the balance in the Retail Settlement Variance Account ("RSVA") Power component of Account 1588. In response to Board staff interrogatory #5e, MPDC recalculated the preset disposition threshold for all Group 1 Account balances for its Newbury, Main and Dutton service areas which showed that in aggregate, the preset disposition threshold would be exceeded. This calculation also excluded the RSVA Power component of Account 1588.

MPDC noted that it inadvertently did not follow the prescribed methodology for the RSVA Power component of Account 1588. MPDC indicated that it has initiated an internal review to determine whether the 2009 and 2010 balances attributable to the RSVA Power component of Account 1588 are in accordance with Article 220 of the Board's *Accounting Procedures Handbook for Electricity Distributors*. In order to allow sufficient time to complete the reconciliations and analysis associated with the internal

review, MPDC requested to dispose of the 2009 and 2010 RSVA Power balances as part of its 2013 IRM application.

MPDC also noted in the Manager's Summary of its application, that there are differences between the Group 1 amounts sought for disposition and the amounts reported as part of the *Reporting and Record-keeping Requirements* ("RRR"). MPDC explained that the Group 1 Account balances for the pre-acquisition period from January 1, 2005 to December 31, 2008 were not accurately reflected in the financial accounts by the previous ownership and were not recorded by MPDC until the Board approved the disposition of the Group 1 Account balances in MPDC's 2011 IRM application (EB-2010-0275). MPDC also noted that the Group 1 Account activities from January 1, 2009 to April 30, 2009 were not included in the 2010 RRR.

MPDC provided a table to illustrate the reconciliation of its ledger to the previously reported RRR balances¹. MPDC confirmed that the amounts in the "Approved Disposition EB-2010-0275" column of the table had the signs reversed. MPDC also noted that it did not attempt to amend its 2012 RRR because the adjustment was identified in the fourth quarter of 2011.

In its submission, Board staff noted that the preset disposition threshold methodology proposed by MPDC is not consistent with the EDDVAR Report. However, Board staff noted that the internal review undertaken by MPDC is likely the reason why it did not include the amount in the RSVA Power component of Account 1588 in the preset disposition threshold calculation. Board staff also noted that the Board stated in the EDDVAR Report that during the IRM plan term the preset disposition threshold level should enhance the distributor's ability to manage its cash flow. Board staff expressed the view that a distributor's cash flow is best reflected at the utility (overall) level and not within each individual rate zone. As such, Board staff suggested that a single threshold test be applied to Group 1 Account balances combined across all rate zones. Board staff also noted that this approach would be consistent with the treatment of the Global Adjustment sub-account balance, in that it is included as part of the total balance used in the threshold test calculation even though the account is disposed to only a sub-set of customers.

Board staff further submitted that the internal review is important to ensure the correctness of the sub-accounts of Account 1588, since the sub-account balances are

allocated to different customer groups based on cost causality. Board staff submitted that the Board should defer the disposition of Account 1588 to MPDC's 2013 rate application.

Board staff further indicated that it reviewed MPDC's reconciliations of the Group 1 principal amounts as of December 31, 2010 and the amounts reported as part of the RRR. Board staff related its understanding that the adjustments were necessary to reconcile the ledger to the amounts approved for disposition on a final basis in the 2011 IRM proceeding (EB-2010-0275), and have no bearings on the amounts sought for disposition in this proceeding. Board staff submitted that the Group 1 Account balances, excluding Account 1588, as of December 31, 2010, including interest projected to April 30, 2012 should be disposed on a final basis. Board staff also submitted that the one-year disposition period is in accordance with the EDDVAR Report and should be approved by the Board.

In its reply submission, MPDC submitted that the combined threshold test approach is not in the best interest of its ratepayers. Due to the nature of the Group 1 Accounts, it is possible to accrue a significant debit balance in one rate zone while accruing an offsetting credit balance in another. MPDC submitted that a combined threshold test may result in a deferral of disposition of Group 1 Accounts that are material to smaller rate zones. MPDC noted that deferral of ultimate disposition to a later point may result in larger rate riders that could create significant rate shock and fluctuation for customers, especially in rate zones such as Newbury, which has 290 customers/connections.

MPDC requested that it be permitted to continue to calculate the preset disposition threshold on an individual rate zone basis until such time as the line loss factors and the Group 1 Account balances are merged between its rate zones.

MPDC concurred with Board staff and submitted that the Board should authorize the disposition of the Group 1 Deferral and Variance Accounts, excluding Account 1588.

The Board finds that in order to mitigate potential cross subsidies between rate zones, MPDC should continue to calculate the preset disposition threshold on an individual rate zone basis until such time as rates across MPDC's rate zones are harmonized and Group 1 Account balances are merged. The Board approves, on a final basis, the disposition of a credit balance of \$24,704 as of December 31, 2010, including interest

as of April 30, 2012 for Group 1 accounts, excluding Account 1588. These balances are to be disposed over a one-year period from May 1, 2012 to April 30, 2013. The rate riders associated with the Group 1 Accounts should apply to customers across MPDC's Newbury rate zone only. The Board also authorizes the deferral of the disposition of Account 1588 until MPDC's 2013 rate application.

The table below identifies the principal and interest amounts approved for disposition for Group 1 Accounts for the Newbury service area.

For accounting and reporting purposes, the respective balance of each Group 1 account approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595 pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*. The date of the journal entry to transfer the approved account balances to the sub-accounts of Account 1595 is the date on which disposition of the balances is effective in rates, which generally is the start of the rate year (e.g. May 1). This entry should be completed on a timely basis to ensure that these adjustments are included in the June 30, 2012 (3rd Quarter) RRR data reported.

Review and Disposition of Account 1521: Special Purpose Charge

The Board authorized Account 1521, Special Purpose Charge Assessment (“SPC”) Variance Account in accordance with Section 8 of *Ontario Regulation 66/10 (Assessments for Ministry of Energy and Infrastructure Conservation and Renewable Energy Program Costs)* (the “SPC Regulation”). Accordingly, any difference between (a) the amount remitted to the Minister of Finance for the distributor’s SPC assessment and (b) the amounts recovered from customers on account of the assessment were to be recorded in “Sub-account 2010 SPC Assessment Variance” of Account 1521.

In accordance with Section 8 of the SPC Regulation, distributors are required to apply no later than April 15, 2012 for an order authorizing the disposition of any residual balance in sub-account 2010 SPC Assessment Variance. The Filing Requirements sets out the Board’s expectation that requests for disposition of this account balance would be heard as part of the proceedings to set rates for the 2012 year.

MPDC requested the disposition of a residual debit balance of \$65 as at December 31, 2010, plus collections in 2011 and carrying costs until April 30, 2012 over a one-year period.

Board staff submitted that despite the usual practice, the Board should authorize the disposition of Account 1521 as of December 31, 2010, plus the amounts recovered from customers in 2011, including interest, because the account balance does not require a prudence review, and electricity distributors are required by regulation to apply for disposition of this account. Board staff submitted that the \$65 debit balance in Account 1521 should be approved for disposition on a final basis.

In its reply submission MPDC agreed with Board staff’s submission.

The Board approves, on a final basis, the disposition of the principal and interest balances as of April 30, 2012 totaling a debit of \$65 in Account 1521 over a one-year period from May 1, 2012 to April 30, 2013. . The Board directs MPCD to close Account 1521 as of May 1, 2012.

For accounting and reporting purposes, the balance of Account 1521 shall be transferred to the applicable principal and interest carrying charge sub-accounts of

Account 1595 pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*. The date of the journal entry to transfer the approved account balances to the sub-accounts of Account 1595 is the date on which disposition of the balances is effective in rates, which generally is the start of the rate year (e.g. May 1). This entry should be completed on a timely basis to ensure that these adjustments are included in the June 30, 2012 (3rd Quarter) RRR data reported.

Rate Model

With this Decision, the Board is providing MPDC with a rate model (spreadsheet) and applicable supporting models and a draft Tariff of Rates and Charges (Appendix A) that reflects the elements of this Decision. The Board also reviewed the entries in the rate model to ensure that they were in accordance with the 2011 Board approved Tariff of Rates and Charges and the rate model was adjusted, where applicable, to correct any discrepancies.

THE BOARD ORDERS THAT:

1. MPDC's new distribution rates shall be effective May 1, 2012.
2. MPDC shall review the draft Tariff of Rates and Charges set out in Appendix A. MPDC shall file with the Board a written confirmation assessing the completeness and accuracy of the draft Tariff of Rates and Charges, or provide a detailed explanation of any inaccuracies or missing information within **7 days** of the date of issuance of this Decision and Order.
3. If the Board does not receive a submission from MPDC to the effect that inaccuracies were found or information was missing pursuant to item 2 of this Decision and Order, the draft Tariff of Rates and Charges set out in Appendix A of this Decision and Order will become final effective May 1, 2012, and will apply to electricity consumed or estimated to have been consumed on and after May 1, 2012. MPDC shall notify its customers of the rate changes no later than with the first bill reflecting the new rates.
4. If the Board receives a submission from MPDC to the effect that inaccuracies were found or information was missing pursuant to item 2 of this Decision and Order, the

Board will consider the submission of MPDC and will issue a final Tariff of Rates and Charges.

All filings to the Board must quote file number **EB-2011-0150**, be made through the Board's web portal at, www.errr.ontarioenergyboard.ca and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available parties may email their document to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

RESIDENTIAL SERVICE CLASSIFICATION

If a service supplies a combination of residential and commercial load and wiring does not permit separate metering, the classification of this customer will be determined individually by the distributor. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Board, and amendments thereto as approved by the Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Board, and amendments thereto as approved by the Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable.

It should be noted that this schedule does not list any charges, assessments or credits that are required by law to be invoiced by a distributor and that are not subject to Board approval, such as the Debt Retirement Charge, the Global Adjustment, the Ontario Clean Energy Benefit and the HST.

Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Board, and amendments thereto as approved by the Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Board, and amendments thereto as approved by the Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable.

It should be noted that this schedule does not list any charges, assessments or credits that are required by law to be invoiced by a distributor and that are not subject to Board approval, such as the Debt Retirement Charge, the Global Adjustment, the Ontario Clean Energy Benefit and the HST.
