AND IN THE MATTER OF an application by Sioux Lookout Hydro Inc. for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2013.

PROCEDURAL ORDER NO. 2

May 13, 2013

Sioux Lookout Hydro Inc. ("SLHI") filed a complete application (the "Application") with the Ontario Energy Board (the "Board") on February 22, 2013 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that SLHI charges for electricity distribution, to be effective May 1, 2013.

In Procedural Order No. 1, issued on April 1, 2013, the Board granted the Vulnerable Energy Consumers Coalition ("VECC") intervenor status and cost eligibility, and set dates for interrogatories and interrogatory responses.

Subsequently, the Board granted Mr. Douglas A. Shields intervenor status.

Written interrogatories were filed by Mr. Shields on April 15, 2013, by Board staff on April 18, 2013 and by VECC on April 19, 2013. SLHI filed responses to all interrogatories on May 3, 2013.

After reviewing the responses to the interrogatories, the Board has decided that provision should be made for further written interrogatories for the sole purpose of clarifying the information already provided in the responses filed by SLHI.

The Board reminds parties that interrogatories must reference the pre-filed evidence and, in accordance with *Chapter 1 of the Filing Requirements for Transmission and Distribution Applications* ("Filing Requirements"), parties must sort their interrogatories and responses by topics as outlined in the exhibits in the Filing Requirements. A continuous numbering system should be used to facilitate subsequent referencing of the interrogatories. The Board is also making provision for written submissions at this time.

The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

1. Board staff, VECC and Mr. Shields, if they wish further information and material from SLHI to clarify the information provided in the responses to interrogatories filed by SLHI in accordance with Procedural Order No. 1 and that is relevant to the Application, shall request it by written supplemental interrogatories filed with the Board and delivered to SLHI, VECC and Mr. Shields on or before **May 24, 2013**.
2. SLHI shall file with the Board complete written responses to the supplemental interrogatories and serve them on VECC and Mr. Shields on or before **June 5, 2013**.
3. Board staff shall file a written submission, if any, with the Board, and deliver it to SLHI, VECC and Mr. Shields, by **June 28, 2013**.
4. VECC and Mr. Shields, if they so wish, may make a written submission on the Application and must file that submission with the Board, and deliver it to SLHI and the other intervenor, by **June 28, 2013**.
5. If SLHI wishes to respond to a submission, the reply submission must be filed with the Board and delivered to VECC and Mr. Shields by **July 12, 2013**.

All filings to the Board must quote the file number, **EB-2012-0165**, be made through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax

number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below.
