**Re: Tillsonburg Hydro Inc.
2013 Cost of Service Rate Application
Correction to Tariff of Rates and Charges
Board File No. EB-2012-0168**

On July 17, 2013, subsequent to the Board issuing its Decision and Order dated April 9, 2013 in this matter, Tillsonburg Hydro Inc. ("THI") notified the Board that it became aware of three typographical errors in the continuity schedule filed in support of the settlement agreement approved by the Board.

In the "Interest Disposition during 2012 – Instructed by Board" column of the continuity schedule (shown on page 120 of the Settlement Agreement), the interest disposition for Group 1 deferral and variance accounts 1580 WMS, 1588 Power and 1588 sub-account Global Adjustment were entered without the negative sign. In its letter, THI noted that the overall result of this error is to understate the "Rate Rider for Disposition of Deferral/Variance Accounts (2013) – effective until April 30, 2014" and the "Rate Rider for Disposition of Global Adjustment Sub-Account (2013) – effective until April 30, 2014" for each class for an approximately \$51,000 loss to the distributor. THI requested that the Board consider a correction to the rate riders, as the amount was material for a distributor of its size. THI stated that it understands that the Board cannot make a retroactive correction but, instead, asked that the Board consider a correction, going forward.

Pursuant to its powers under Rule 43.02 of the Board's Rules of Practice and Procedure, the Board may at any time, without notice or a hearing of any kind, correct a typographical error, error of calculation or similar error made in its orders or decisions. The Board considers this to be an error in a calculation based on a typographical error. The revised Tariff of Rates and Charges is attached. The Board accepts THI's proposal to correct the Tariff of Rates and Charges, going forward. The calculation of the revised rate riders can be found in the attached 2013 Deferral/Variance Account Workform. This revised Tariff of Rates and Charges replaces the corrected tariff issued by the Board on May 23, 2013. These corrected rates will be effective August 1, 2013. The Decision itself is not changed in any way.
