DO SOLEMNLY DECLARE THAT

I am Manager, Regulatory Affairs for Burlington Hydro Inc., and as such have knowledge of the matters herein deposed to:


1. I caused the Notice to Customers of Burlington Hydro Inc. to be published in the Burlington Post on November 21, 2013, which is within 14 days of the date of the Ontario Energy Board's Letter of Direction.
2. According to the best information available, I believe that the Burlington Post is the English-language newspaper having the highest circulation in Burlington Hydro Inc.'s service area.
3. A copy of the advertisement is attached hereto as Schedule "A" to this Affidavit.
4. The published Notice inadvertently stated that applications from intervenors must be received by November 30, 2013, which is 9 (nine) calendar days from the date of publication. The Notice should have stated that the last day for receiving applications from intervenors was December 01, 2013. As November 30, 2013 was a Saturday and December 01, 2013 was a Sunday, the actual last day for receiving applications from intervenors was Monday, December 02, 2013, which is the same actual last day had the published Notice correctly stated that the last day for receiving applications from intervenors was December 01, 2013. I have been advised by Ontario Energy Board staff that in the opinion of the Board Legal Department, it was not necessary to republish the Notice, as the de facto date for receiving applications from intervenors was the same in either case.
5. A copy of the Notice to Customers of Burlington Hydro Inc. was served by courier on all intervenors of record in the previous cost of service rate application proceeding EB-2009-0259.
6. A list of the intervenors of record in EB-2009-0259 is attached hereto as Schedule "B" to this Affidavit.

7. A copy of the FedEx Courier shipping labels pertinent to the intervenors of record in EB-2009-0259 is attached as Schedule "C" to this Affidavit. The shipping date of all intervenors of record was November 14, 2013.
8. Burlington Hydro Inc. has no Embedded Distributors and no Notices were served pursuant to paragraph 4 of the said Ontario Energy Board Letter of Direction.
9. Copies of the Notice, application and evidence have been posted on Burlington Hydro Inc.'s website and are available for review at Burlington Hydro Inc.'s office.
