DECISION and RATE ORDER

March 13, 2014

Renfrew Hydro Inc. (“Renfrew Hydro”) filed an application with the Ontario Energy Board (the “Board”) on September 13, 2013 under section 78 of the Act, seeking approval for changes to the rates that Renfrew Hydro charges for electricity distribution, effective May 1, 2014 (the “Application”).

The Application met the Board’s requirements as detailed in the *Report of the Board: Renewed Regulatory Framework for Electricity Distributors: A Performance-Based Approach* (the “RRFE Report”) dated October 18, 2012 and the *Filing Requirements for Electricity Distribution Rate Applications* (the “Filing Requirements”) dated July 17, 2013. Renfrew Hydro selected the Annual IR Index option to adjust its 2014 rates. The Annual IR Index methodology provides for a mechanistic and formulaic adjustment to distribution rates and charges in the period between cost of service applications. Renfrew Hydro last appeared before the Board with a full cost of service application for the 2010 rate year in the EB-2009-0146 proceeding.

The Board conducted a written hearing and Board staff participated in the proceeding. No letters of comment were received.

While I have considered the entire record in this proceeding, I have made reference only to such evidence as is necessary to provide context to my findings. The following issues are addressed in this Decision and Rate Order:

- Price Cap Index Adjustment;
- Rural or Remote Electricity Rate Protection Charge;
- Shared Tax Savings Adjustments;
- Retail Transmission Service Rates; and
- Review and Disposition of Group 1 Deferral and Variance Account Balances.

Price Cap Index Adjustment

The Board issued the *Report on Rate Setting Parameters and Benchmarking under the Renewed Regulatory Framework for Ontario's Electricity Distributors* (the "Price Cap IR Report") which provides the 2014 rate adjustment parameters for distribution companies selecting either the Price Cap IR or Annual IR Index option.

Distribution rates under the Annual IR Index option are adjusted by an inflation factor, less a productivity factor and a stretch factor. The inflation factor for 2014 rates is 1.7%. Based on the total cost benchmarking model developed by Pacific Economics Group Research, LLC, the Board determined that the appropriate value for the productivity factor is zero percent. The stretch factor is 0.6% for distributors selecting the Annual IR Index option.

As a result, the net price cap index adjustment for Renfrew Hydro is 1.10% (i.e. 1.7% - (0% + 0.6%)). The price cap index adjustment applies to distribution rates (fixed and variable charges) uniformly across all customer classes. The price cap index adjustment does not apply to the components of delivery rates set out in the list below:

- Rate Riders;
- Rate Adders;
- Low Voltage Service Charges;
- Retail Transmission Service Rates;
- Wholesale Market Service Rate;

- Rural or Remote Electricity Rate Protection Charge;
- Standard Supply Service – Administrative Charge;
- Transformation and Primary Metering Allowances;
- Loss Factors;
- Specific Service Charges;
- MicroFit Charge; and,
- Retail Service Charges.

Rural or Remote Electricity Rate Protection Charge

The Board issued a Decision and Rate Order (EB-2013-0396) establishing the Rural or Remote Electricity Rate Protection (“RRRP”) benefit and charge for 2014. The Board determined that the RRRP charge to be paid by all rate regulated distributors and collected by the Independent Electricity System Operator (“IESO”) shall be increased to \$0.0013 per kWh effective May 1, 2014 from the current \$0.0012 per kWh. The draft Tariff of Rates and Charges flowing from this Decision and Rate Order reflects the new RRRP charge.

Shared Tax Savings Adjustments

In its *Supplemental Report of the Board on 3rd Generation Incentive Regulation for Ontario’s Electricity Distributors*, the Board determined that a 50/50 sharing of the impact of legislated tax changes between shareholders and ratepayers is appropriate.

The tax reduction will be allocated to customer rate classes on the basis of the last Board approved cost of service distribution revenue.

In its Application, Renfrew Hydro noted that it input tax credits of \$2,486 for apprenticeship training to reflect the actual credit claimed for the 2012 tax year, as opposed to the initial \$14,500 that was approved as part of its 2010 cost of service application (EB-2009-0146).

In its responses to interrogatories, Renfrew Hydro requested that Board staff advise if this is an error and it will re-enter the 2010 cost of service value of \$14,500 and re-submit the Tax-Sharing Model.

In its submission, Board staff noted that with the reduced tax credits of \$2,486, the Tax-Sharing Model calculates incremental tax savings of a debit of \$9,445 with \$4,722 (50%) to be collected from ratepayers. With the full amount of tax credits entered, the incremental tax savings is a credit of \$4,181, with \$2,091 being refunded to ratepayers. The Tax-Sharing Model utilizes the base tax rates that are approved as part of a distributor's rebasing application to determine the changes in taxes from the rebasing year to the test year. The calculations built into the Tax-Sharing Model are designed to include the full tax credits which the distributor included in its 2010 rebasing application.

Renfrew Hydro did not file a reply submission.

I direct Renfrew Hydro to refund to customers a tax sharing amount of \$2,091. The Supplemental Report of the Board on 3rd Generation Incentive Regulation for Ontario's Electricity Distributors states as follows:

Therefore, for 3rd Generation IR, the Board has determined that a 50/50 sharing of the impact of currently known legislated tax changes, as applied to the tax level reflected in the Board-approved base rates for a distributor, is appropriate.

The sharing is therefore related to legislated changes, not changes related to tax credits taken by a distributor.

The amount of \$2,091 results in rate riders for the Residential and General Service < 50kW rate classes that are immaterial when rounded to four decimal places; therefore Renfrew Hydro shall record this balance in variance Account 1595 by June 30, 2014 for disposition at a future date.

Retail Transmission Service Rates

Electricity distributors are charged for transmission costs at the wholesale level and then pass these charges on to their distribution customers through the Retail Transmission Service Rates ("RTSRs"). Variance accounts are used to capture differences in the rate that a distributor pays for wholesale transmission service compared to the retail rate that the distributor is authorized to charge when billing its customers (i.e. variance Accounts 1584 and 1586).

The Board issued revision 3.0 of the *Guideline G-2008-0001 - Electricity Distribution Retail Transmission Service Rates* (the “RTSR Guideline”) which outlines the information that the Board requires electricity distributors to file to adjust their RTSRs for 2014. The RTSR Guideline requires electricity distributors to adjust their RTSRs based on a comparison of historical transmission costs adjusted for the new Uniform Transmission Rates (“UTR”) levels and the revenues generated under existing RTSRs. Similarly, embedded distributors, such as Renfrew Hydro, must adjust their RTSRs to reflect any changes to the applicable Sub-Transmission RTSRs of their host distributor(s), e.g. Hydro One Networks Inc.

The Board approved new rates for Hydro One Sub-Transmission class, including the applicable RTSRs, effective January 1, 2014 (EB-2013-0141), as shown in the following table.

2014 Sub-Transmission RTSRs

Network Service Rate	\$3.23 per kW
<u>Connection Service Rates</u>	
Line Connection Service Rate	\$0.65 per kW
Transformation Connection Service Rate	\$1.62 per kW

I find that these 2014 Sub-Transmission class RTSRs are to be incorporated into the calculation of Renfrew Hydro’s RTSRs. Accordingly the rate models that accompany this Decision and Rate Order have been updated to include these rates.

Review and Disposition of Group 1 Deferral and Variance Account Balances

The *Report of the Board on Electricity Distributors’ Deferral and Variance Account Review Initiative* provides that, during the IRM plan term, the distributor’s Group 1 account balances will be reviewed and disposed if the preset disposition threshold of \$0.001 per kWh (debit or credit) is exceeded. The onus is on the distributor to justify why any account balance in excess of the threshold should not be disposed.

Renfrew Hydro’s 2012 actual year-end total balance for Group 1 Accounts including interest projected to April 30, 2014 is a debit of \$19,238. This amount results in a total debit claim of \$0.0002 per kWh, which does not exceed the preset disposition threshold. Renfrew Hydro did not seek disposition of balances in its Application.

In its submission, Board staff noted that the principal amounts as of December 31, 2012 reconcile with the amounts reported as part of the *Reporting and Record-keeping Requirements*.

I find that no disposition is required at this time given that the disposition threshold has not been exceeded.

Rate Model

With this Decision and Rate Order, the Board is providing Renfrew Hydro with a rate model, applicable supporting models and a draft Tariff of Rates and Charges (Appendix A). The Board also reviewed the entries in the rate model to ensure that they were in accordance with the 2013 Board approved Tariff of Rates and Charges and the rate model was adjusted, where applicable, to correct any discrepancies.

THE BOARD ORDERS THAT:

1. Renfrew Hydro's new distribution rates shall be effective May 1, 2014.
2. Renfrew Hydro shall review the draft Tariff of Rates and Charges set out in Appendix A and shall file with the Board, as applicable, a written confirmation of its completeness and accuracy, or provide a detailed explanation of any inaccuracies or missing information, within **7 days** of the date of issuance of this Decision and Rate Order.
3. If the Board does not receive a submission from Renfrew Hydro to the effect that inaccuracies were found or information was missing pursuant to item 2 of this Decision and Rate Order, the draft Tariff of Rates and Charges set out in Appendix A of this Decision and Rate Order will become final. Renfrew Hydro shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.
4. If the Board receives a submission from Renfrew Hydro to the effect that inaccuracies were found or information was missing pursuant to item 2 of this Decision and Rate Order, the Board will consider the submission of Renfrew Hydro prior to issuing a final Tariff of Rates and Charges.

5. Renfrew Hydro shall pay the Board's costs incidental to this proceeding upon receipt of the Board's invoice.

Those who do not have computer access are required to file 2 paper copies.
