**ONTARIO ENERGY BOARD NOTICE  
TO CUSTOMERS OF CENTRE WELLINGTON HYDRO LTD.**

**Centre Wellington Hydro Ltd. has applied to lower its  
electricity distribution rates.  
Learn more. Have your say.**

Centre Wellington Hydro Ltd. has applied to the Ontario Energy Board to decrease the amount it charges by approximately \$1.85 each month for the typical residential customer beginning on May 1, 2015. Other customers, including businesses, may be affected as well.

The rate change is a decrease because certain temporary charges are scheduled to end at the same time as Centre Wellington Hydro is requesting a formulaic rate adjustment tied to inflation and other factors.

**THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING**

The Ontario Energy Board (OEB) will hold a public hearing to consider Centre Wellington Hydro's request. We will determine whether Centre Wellington Hydro has used the applicable models and formulas as required by the OEB. At the end of this hearing, the OEB will decide on the appropriate rate changes.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

**BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process. You can:

- review Centre Wellington Hydro's application on the OEB's website now;
- file a letter with your comments, which will be considered during the hearing;
- become an active participant (called an intervenor). Apply by October 27, 2014 or the hearing will go ahead without you and you will not receive any further notice of the proceeding;
- at the end of the process, review the OEB's decision and its reasons on our website.

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction on Cost Awards* and are in relation to Centre Wellington Hydro's request for the approval of a new deferral account to track the impact of conservation programs by the Township of Centre Wellington.

**LEARN MORE**

These proposed charges relate to Centre Wellington Hydro's distribution services. They make up part of the Delivery line - one of the five line items on your bill. If you apply to become an intervenor, all information will be public.*
