

ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF CAMBRIDGE AND NORTH DUMFRIES HYDRO INC.

**Cambridge and North Dumfries Hydro Inc. has applied to raise its electricity distribution rates.
Learn more. Have your say.**

Cambridge and North Dumfries Hydro Inc. has applied to the Ontario Energy Board to increase the amount it charges by approximately \$0.08 each month for the typical residential customer beginning on May 1, 2015. Other customers, including businesses, may be affected as well.

The requested rate increase is set using a formula which is tied to inflation and other factors intended to promote efficiency. The rate increase also includes Cambridge and North Dumfries Hydro's request to recover costs for damage caused by an ice storm in late December, 2013.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Cambridge and North Dumfries Hydro's request. We will determine whether Cambridge and North Dumfries Hydro has used the applicable models and formulas as required by the OEB. At the end of this hearing, the OEB will decide on the appropriate rate changes.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review Cambridge and North Dumfries Hydro's application on the OEB's website now;
- file a letter with your comments, which will be considered during the hearing;
- become an active participant (called an intervenor). Apply no later than **10 calendar days** after the publication or service date of this notice or the hearing will go ahead without you and you will not receive any further notice of the proceeding;
- at the end of the process, review the OEB's decision and its reasons on our website.

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction on Cost Awards* and are in relation to Cambridge and North Dumfries Hydro's proposed Z-factor ice storm claim and its request to clear the balance in an account which tracks the difference between the actual revenue impacts of conservation programs compared to what Cambridge and North Dumfries Hydro had predicted.

These proposed charges relate to Cambridge and North Dumfries Hydro's distribution services. They make up part of the Delivery line - one of the five line items on your bill. WRITTEN HEARING

There are two types of OEB hearings – oral and written. Cambridge and North Dumfries Hydro has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why.

PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
