AND IN THE MATTER OF an application by Centre Wellington Hydro Ltd. for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2015.

PROCEDURAL ORDER NO. 1

November 4, 2014

Centre Wellington Hydro Ltd. ("Centre Wellington Hydro") filed a complete application (the "Application") with the Ontario Energy Board (the "Board") on September 25, 2014 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the Board's Filing Requirements for Incentive Regulation Rate Applications. Centre Wellington Hydro is seeking approval for changes to the rates that Centre Wellington Hydro charges for electricity distribution, to be effective May 1, 2015. The Board assigned the application file number EB-2014-0062.

The Board issued a Notice of Application and Hearing on October 9, 2014. The Vulnerable Energy Consumers Coalition ("VECC") applied for intervenor status and cost eligibility in relation to Centre Wellington Hydro's request for the approval of a new deferral account to track the impact of conservation programs by the Township of Centre Wellington. No objection was received.

I approve VECC as an intervenor and that VECC is eligible to apply for an award of costs under the Board's *Practice Direction on Cost Awards* in relation to Centre Wellington Hydro's request outlined above.

The list of parties in this proceeding is attached as Appendix A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the Board's *Rules of Practice and Procedure* (as revised April 24, 2014) regarding required naming and numbering conventions and other matters related to interrogatories.

I consider it necessary to make provision for the following matters related to this proceeding. Provision is being made for written submissions following the filing of interrogatory responses, unless the Board orders otherwise during the course of the proceeding. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

1. Board staff and VECC shall request any information and material from Centre Wellington Hydro that is in addition to Centre Wellington Hydro's pre-filed evidence with the Board, and that is relevant to the hearing, by written interrogatories filed with the Board and served on Centre Wellington Hydro on or before **November 17, 2014**.
2. Centre Wellington Hydro shall file with the Board complete written responses to the interrogatories and serve them on VECC on or before **December 1, 2014**.
3. Unless the Board orders otherwise, Board staff and VECC wishing to file a written submission shall do so by **December 15, 2014**. Any submission should be filed with the Board and delivered to Centre Wellington Hydro and VECC.
4. Unless the Board orders otherwise, Centre Wellington Hydro may file a written reply submission with the Board, and deliver it to VECC by **January 12, 2015**.

All filings to the Board must quote the file number, EB-2014-0062 and be made electronically through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/> in searchable / unrestricted PDF format. Two paper copies must also be filed at the Board's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two

paper copies. Those who do not have computer access are required to file 7 paper copies.
