DECISION and RATE ORDER

December 4, 2014

Guelph Hydro Electric Systems Inc. (“Guelph Hydro”) filed an application with the Ontario Energy Board (the “Board”) on August 13, 2014 under section 78 of the *Ontario Energy Board Act*, seeking approval for changes to the rates that Guelph Hydro charges for electricity distribution, effective January 1, 2015 (the “Application”).

Guelph Hydro last appeared before the Board with a cost of service application for the 2012 rate year in the EB-2011-0123 proceeding. To adjust its 2015 rates, Guelph Hydro selected the Price Cap Incentive Rate-setting option (the “Price Cap IR”) which provides for a mechanistic and formulaic adjustment to distribution rates and charges in the period between cost of service proceedings. The Application met the Board’s filing

requirements¹ for filings by rate-regulated electricity distributors (“distributors”) applying for annual rate adjustments under Price Cap IR.

The Board conducted a written hearing and Board staff participated in the proceeding. The Vulnerable Energy Consumers Coalition (“VECC”) applied for and was granted intervenor status and cost eligibility with respect to Guelph Hydro’s renewable generation funding adder. No letters of comment were received.

While the entire record in this proceeding has been considered by the Board, this decision will make reference only to such evidence as is necessary to provide context to the Board’s findings. The following issues are addressed in this Decision and Rate Order:

- Price Cap Index Adjustment;
- Rural or Remote Electricity Rate Protection Charge;
- Shared Tax Savings Adjustments;
- Retail Transmission Service Rates;
- Review and Disposition of Group 1 Deferral and Variance Account Balances;
- Disposition of Deferral and Variance Accounts for Class A Customers; and
- Green Energy Act Plan Funding Adder.

Price Cap Index Adjustment

The Price Cap IR option is a streamlined regulatory process designed to provide distributors with sufficient revenue to cover cost increases due to inflation while providing an incentive structure to drive productivity improvements.

Under the Price Cap IR option², distribution rates are adjusted by an inflation factor, less the sum of a productivity factor and a stretch factor. Based on its established method³, the Board has set the inflation factor for 2015 rates at 1.6% and the productivity factor remains zero percent. The Board also determined that the stretch factor can range from 0.0% to 0.6%, assigned based on a distributor’s cost evaluation ranking. The Board assigned Guelph Hydro a stretch factor of 0.3% based on the updated benchmarking

study for use for rates effective in 2015⁴.

As a result, the net price cap index adjustment for Guelph Hydro is 1.30% (i.e. 1.6 % - (0% + 0.30%)). The price cap index adjustment applies to distribution rates (fixed and variable charges) uniformly across all customer classes. The price cap index adjustment does not apply to the components of delivery rates set out in the list below:

- Rate Riders;
- Rate Adders;
- Low Voltage Service Charges;
- Retail Transmission Service Rates;
- Wholesale Market Service Rate;
- Rural or Remote Electricity Rate Protection Charge;
- Standard Supply Service – Administrative Charge;
- Transformation and Primary Metering Allowances;
- Loss Factors;
- Specific Service Charges;
- MicroFit Charge; and
- Retail Service Charges.

Rural or Remote Electricity Rate Protection Charge

As of the date of this Decision and Rate Order, the Board has not issued a decision on the Rural or Remote Electricity Rate Protection (“RRRP”) charge for 2015. In the event that a new charge is established for 2015, the RRRP rate order will supersede this Decision and Rate Order with respect to the RRRP charge currently set at \$0.0013/kWh.

Shared Tax Savings Adjustments

The Board has determined that a 50/50 sharing of the impact of legislated tax changes between shareholders and ratepayers is appropriate⁵.

The tax reduction will be allocated to customer rate classes on the basis of the Board-approved distribution revenue from Guelph Hydro's last cost of service proceeding.

The Application identified a total tax savings of \$46,034 resulting in a shared amount of \$23,017 to be refunded to rate payers.

In its submission, Board staff noted that the Shared Tax-Savings portion of the Rate Generator Model reflects the Revenue Requirement Work Form from the Board's cost of service decision in EB-2011-0123. Board staff had no concerns with the information as filed.

The Board approves the disposition of the shared tax savings of \$23,017 based on a volumetric rate rider using annualized consumption for all customer classes over a one-year period from January 1, 2015 to December 31, 2015.

Retail Transmission Service Rates

Electricity distributors are charged for transmission costs at the wholesale level and then pass on these charges to their distribution customers through their Retail Transmission Service Rates ("RTSRs"). Variance accounts 1584 and 1586 are used to capture differences in the rate that a distributor pays for wholesale transmission service relative to the retail rate that the distributor is authorized to charge when billing its customers.

The Board has issued guidelines⁶ which outline the information that the Board requires electricity distributors to file in order to adjust their RTSRs for 2015. The RTSR guideline requires electricity distributors to adjust their RTSRs based on a comparison of historical transmission costs adjusted for the new Uniform Transmission Rates and the revenues generated under existing RTSRs. Similarly, partially embedded distributors, such as Guelph Hydro, must adjust their RTSRs to reflect any changes to the applicable RTSRs of their host distributor, which is Hydro One Networks Inc.

Given the timing of rates decisions, distributors whose rates are set as of January 1 typically derive their RTSRs using the previous year's Uniform Transmission Rates because updated ones are not yet available. As with past years, the Board has not yet adjusted Uniform Transmission Rates and Hydro One sub-transmission class rates for

2015. The Board will therefore approve the RTSRs as adjusted in this Application so that they reflect the current applicable rates. The differences arising from the new 2015 rates, once approved, will be captured in Accounts 1584 and 1586 for future disposition.

Review and Disposition of Group 1 Deferral and Variance Account Balances

The Board's policy on deferral and variance accounts⁷ provides that, during the IRM plan term, the distributor's Group 1 account balances will be reviewed and disposed if the preset disposition threshold of \$0.001 per kWh, whether in the form of a debit or credit, is exceeded. The onus is on the distributor to justify why any account balance in excess of the threshold should not be disposed. If the balances are below this threshold, the distributor may propose to dispose of balances.

Guelph Hydro's 2013 actual year-end total balance for Group 1 accounts including interest projected to December 31, 2014 is a debit of \$6,965,880. This amount results in a total debit claim of \$0.0042 per kWh, which exceeds the preset disposition threshold. Guelph Hydro proposes to dispose of this debit amount over a one-year period.

In its submission, Board staff noted that the principal balances as of December 31, 2013 reconcile with the balances reported as part of the *Reporting and Record-Keeping Requirements*. Accordingly, Board staff had no issue with Guelph Hydro's request to dispose of its 2013 Deferral and Variance Account balances at this time.

Board staff calculated the bill impacts for the general service rate classes between 50 kW and 4,999 kW based on a one-year recovery period as follows:

Total bill impacts for the GS 50 to 999 kW class:

- 100 kW consumption: 8.53%
- 500 kW consumption: 8.73%
- 1,000 kW consumption: 8.76%

Total bill impacts for the GS 1,000 to 4,999 kW class:

- 1,000 kW consumption: 7.63%
- 2,500 kW consumption: 7.67%
- 4,999 kW consumption: 7.68%

Board staff noted that the bill impacts appeared substantial and indicated that a two-year recovery period may help mitigate the impacts for both of these general service classes.

In its reply submission, Guelph Hydro noted that its next cost of service proceeding is scheduled for 2016 rates and that a two-year disposition period of the deferral and variance accounts in question would overlap the 2016 rate changes, and could lead to high rate impacts for these classes in 2016. Conversely, a one year disposition period for the deferral and variance accounts proposed to be disposed in this Application could help to mitigate the 2016 bill impacts.

The balances proposed for disposition are the same as the amounts reported as part of the Board's *Reporting and Record-Keeping Requirements*. The Board approves the disposition of a debit balance of \$6,965,880 as of December 31, 2013, including interest as of December 31, 2014 for Group 1 accounts. These balances are to be disposed over a one-year period from January 1, 2015 to December 31, 2015 to coincide with Guelph Hydro's next cost of service application. The Board notes that the bill impact is below the 10% limit often used by the Board to determine acceptability of the impact. In addition, a one-year disposition period minimizes inter-generational inequity.

The following table identifies the principal and interest amounts which the Board approves for disposition.

The balance of each Group 1 account approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*, effective January 1, 2012. The date of the transfer must be the same as the effective date for the associated rates, which is, generally, the start of the rate year. Guelph Hydro should ensure these adjustments are included in the reporting period ending March 31, 2015 (Quarter 1).

Disposition of Deferral and Variance Accounts for Class A Customers

As indicated in the Filing Requirements⁸, distributors must establish separate rate riders to recover the balances in the retail settlement variance accounts from Market Participants in order that they not be allocated any balances related to charges for which the Market Participants settle directly with the IESO (e.g. wholesale energy, wholesale market services).

The Board further determined that a distributor who serves Class A customers per Ontario Regulation 429/04 must propose an appropriate allocation for the recovery of the global adjustment variance balance based on its settlement process with the IESO.

Guelph Hydro noted that its settlement process with the IESO with respect to Class A customers in regard to the contribution to the balance of Account 1589 – Global Adjustment offsets to zero. Therefore, Guelph Hydro is not proposing to charge a rate rider for the disposition of this account to Class A customers. The Board agrees that no disposition of this account to Class A customers is required.

Green Energy Act Plan Funding Adder

In Guelph Hydro's 2012 cost of service decision EB-2011-0123, the Board approved the Green Energy Act ("GEA") Plan Funding Adders from April 1, 2012 until March 31, 2015. The rate riders approved were as follows:

- April 1, 2012 to March 31, 2013: \$0.10
- April 1, 2013 to March 31, 2014: \$0.14
- April 1, 2014 to March 31, 2015: \$0.15

Prior to the filing of the current Application, it was brought to Guelph Hydro's attention that the approved GEA model from its previous cost of service application contained a formula error. As a result of this error, Guelph Hydro will over-collect an amount of \$4,702.75 from April 1, 2014 to December 31, 2014. In this proceeding, Guelph Hydro seeks to make corrections to its 2014 GEA Plan Funding Adder from January 1, 2015 until March 31, 2015, to rectify the over-collection.

Board staff noted that on page 18 of the Filing Requirements, the Board stated that "the cost recovered through the funding adder will be subject to a prudence review in the first cost of service application following the implementation of the funding adder".

Board staff submitted that the amount of over collection was immaterial and would be true-up in Guelph Hydro's next cost of service rates proceeding. Board staff submitted that Guelph Hydro should continue to apply the GEA Funding Adder that was approved in its previous cost of service proceeding (i.e. \$0.15).

VECC submitted that it is reasonable to wait until Guelph Hydro's next cost of service rate application for 2016 rates when the true-up of the GEA funding adder would be subject to a prudence review.

In its reply submission, Guelph Hydro agreed with the submissions of Board staff and VECC.

The Board finds it appropriate to defer this issue until Guelph Hydro's next cost of service application, pending a review and reconciliation of the funding adders.

Rate Model

With this Decision and Rate Order, the Board is providing Guelph Hydro with a rate model, applicable supporting models and a draft Tariff of Rates and Charges (Appendix A). The Board also reviewed the entries in the rate model(s) to ensure that they were in accordance with the 2014 Board-approved Tariff of Rates and Charges. The rate model was adjusted, where applicable, to correct any discrepancies.

THE BOARD ORDERS THAT:

1. Guelph Hydro's new distribution rates shall be effective January 1, 2015.
2. Guelph Hydro shall review the draft Tariff of Rates and Charges set out in Appendix A and shall file with the Board, as applicable, a written confirmation of its completeness and accuracy, or provide a detailed explanation of any inaccuracies or missing information, within **7 days** of the date of issuance of this Decision and Rate Order.
3. If the Board does not receive a submission from Guelph Hydro to the effect that inaccuracies were found or information was missing pursuant to item 2 of this Decision and Rate Order, the draft Tariff of Rates and Charges set out in Appendix A of this Decision and Rate Order will become final. Guelph Hydro shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.
4. If the Board receives a submission from Guelph Hydro to the effect that inaccuracies were found or information was missing pursuant to item 2 of this Decision and Rate Order, the Board will consider the submission of Guelph Hydro prior to issuing a final Tariff of Rates and Charges.
5. Guelph Hydro shall pay the Board's costs incidental to this proceeding upon receipt of the Board's invoice.

COST AWARDS

The Board will issue a separate decision on cost awards once the following steps are completed:

1. VECC shall submit its cost claims no later than **7 days** from the date of issuance of the final Rate Order.
2. Guelph Hydro shall file with the Board and forward to VECC any objections to the claimed costs within **17 days** from the date of issuance of the final Rate Order.
3. VECC shall file with the Board and forward to Guelph Hydro any responses to any objections for cost claims within **24 days** from the date of issuance of the final Rate Order.
4. Guelph Hydro shall pay the Board's costs incidental to this proceeding upon receipt of the Board's invoice.

All filings to the Board must quote the file number, EB-2014-0077 and be made electronically through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/> in searchable / unrestricted PDF format. Two paper copies must also be filed at the Board's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available parties may email their documents to the address below. RESIDENTIAL SERVICE CLASSIFICATION

This classification includes accounts taking electricity at 750 volts or less where the electricity is used exclusively in a separately metered living accommodation. Customers shall be residing in single-dwelling units that consist of a detached house or one unit of a semi-detached, duplex, triplex or quadraplex house, with a residential zoning. Separately metered dwellings within a town house complex or apartment building also qualify as residential customers. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Board, and amendments thereto as approved by the Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Board, and amendments thereto as approved by the Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.

It should be noted that this schedule does not list any charges, assessments or credits that are required by law to be invoiced by a distributor and that are not subject to Board approval, such as the Debt Retirement Charge, the Global Adjustment, the Ontario Clean Energy Benefit and the HST.

GENERAL SERVICE 50 TO 999 KW SERVICE CLASSIFICATION
