Subject: Allstream Inc. Request for Late Intervenor Status – EB-2014-0116, Toronto Hydro-Electric System Limited Application for 2015 Distribution Rates

1. Allstream Inc. (Allstream) hereby files this request for late intervenor status in the above referenced proceeding, in accordance with the Board's Decision and Procedural Order No. 7, issued 23 February 2015. In that decision and order, the Board ruled that Toronto Hydro-Electric System Limited (THESL) did not provide adequate notice of its application to increase its rate for wireline attachments. Although the Board refused to provide the relief requested by Rogers Communications Partnership (Rogers), Allstream, Cogeco Cable Canada LP and Cogeco Data Services Inc. (together, Cogeco), and supported by TELUS Communications Company (TELUS), the Board established procedures "to allow for the concerns of Rogers and the other carriers to be heard". The Board granted late intervenor status to Rogers, and invited other parties to make late intervenor requests, specifically related to the wireline attachment rate, by 26 February 2015.
2. Allstream is a "Canadian Carrier" within the meaning of the *Telecommunications Act*, and has wireline attachments to THESL poles. As such, Allstream has a direct interest in the rate approved by the Board for such attachments.
3. Allstream intends to participate in the proceeding by submitting interrogatories and evidence, answering interrogatories, cross-examining witnesses and submitting argument as required or needed.
