This letter is sent subsequent to and supersedes the letter of May 12, 2015 issued to you from the OEB.

I am writing in respect of the Certificate of Compliance filed by Canadian Energy Protection Corp. (Canadian Energy) on May 6, 2015 for the purposes of the condition of Canadian Energy's licence as described in section 3 of Ontario Regulation 90/99 (Licence Requirements – Electricity Retailers and Gas Marketers).

Karim Karsan has, under delegated authority, completed the OEB's review of the Certificate of Compliance, and this letter acknowledges that the Certificate of Compliance has been completed and signed in accordance with the requirements of Ontario Regulation 90/99 and the Code of Conduct for Gas Marketers. This acknowledgement is provided for the sole purposes of paragraph 4 of section 3 of Ontario Regulation 90/99 and pertains exclusively to the form, content and signature of the Certificate of Compliance. It does not in any way constitute acknowledgement by the OEB of Canadian Energy's actual compliance with any or all applicable legal and regulatory requirements.

The Certificate of Compliance indicates that Canadian Energy is not conducting marketing activities in respect of low volume consumers using the following channels as of May 6, 2015: Trade Shows, Marketer's Place of Business and Telephone Renewals. You are reminded that, as of that date, Canadian Energy may not conduct retailing activities in respect of low volume consumers using those channels until such time as you have filed with the OEB the further Certificate of Compliance required by section 6.2 of the Code of Conduct for Gas Marketers and have received from the OEB written acknowledgement of it.

The acknowledgement set out in this letter is given effective May 13, 2015. This letter, together with your Certificate of Compliance, will be available for viewing at the OEB's offices and will be placed on the OEB's website.
