**Re: Application for Amendment to Electricity Generation Licence – Name Change  
MightySolar LP (EG-2013-0199)**

We are counsel for MightySolar LP (the “Partnership”) and its partners. The Partnership is seeking an amendment to its Electricity Generation Licence numbered EG-2013-0199 (the “Licence”) to change the name listed on the Licence to reflect the conversion of the partnership from a limited partnership to a general partnership.

**Reason for Amendment**

The partners of the Partnership intend to enter into an amended and restated partnership agreement to convert the limited partnership to a general partnership. Following the conversion, the Partnership will be named Concord MightySolar Partnership.

**Description of the Amendment**

The Partnership requests that the name listed on the Licence be amended to **Concord MightySolar Partnership**.

- Executed resolutions authorizing the partners to enter into an amended and restated partnership agreement to convert the limited partnership to a general partnership (Confidential);

**Confidentiality**

Pursuant to Rule 10 of the *Rules of Practice and Procedure*, we request that the resolutions and organization chart filed in support of this application be held confidential. Such corporate organization information is treated as confidential by the Board when included in an application for an Electricity Generation Licence, and we request that the same treatment be applied to this application which is to simply amend the name of the licensee for this Licence.

**Request to Dispose without a Hearing**

We request that this proceeding be disposed of without a hearing as outlined in section 21(4)(b) of the *Ontario Energy Board Act, 1998*. Section 21(4)(b) states that the Board may dispose of a proceeding provided that:

no person, other than the applicant, appellant or licence holder will be adversely affected in a material way by the outcome of the proceeding and the applicant, appellant or licence holder has consented to disposing of a proceeding without a hearing.

The outcome of this proceeding will not adversely affect any person, including the applicant and Licence holder, since the amendment to the Licence is an administrative change, rather than a substantive change. The Partnership consents to disposing of this proceeding without a hearing. The requested amendment poses no material impact to the electrical system or customers.
