3. Enbridge has a direct interest in all matters of jurisdiction, substance, and procedure in the regulation of public utilities, and in any decision of the Ontario Energy Board (the "Board"), which may create a precedent for, or otherwise affect, the Company's own applications.
4. Enbridge purchases certain storage and transportation services from Union Gas Limited ("Union") pursuant to rate schedules approved by the Board.
5. Enbridge reserves the right to be heard in English, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interests, to adduce evidence on specific matters that are relevant to these proceedings, and to present argument.
