- 4) I COULD BE OF NO HELP TO THE ONTARIO GAS CONSUMERS

I EXPECT THAT I NEVER WILL BE RECEIVING
"THE STORAGE DEVELOPMENT TASK FORCE REPORT"
ASKED FOR IN MY LETTER DATED APRIL, 14, 2017 AND
THEREFORE I HAVE NO EVIDENCE AS TO THE VALUE OF
USING MY STORAGE SPACE BY UNION GAS

I AM NOW REFERRING TO BEING COMPENSATED ON A
ROYALTY BASIS OF $\frac{1}{8}$ ON THE PROFIT UNION GAS IS MAKING
BY USING MY STORAGE SPACE YEARLY

IT IS AN ESTABLISHED FACT AND WIDELY ACCEPTED FOR
MANY YEARS AND COMMON LAW THAT ROYALTY PAYMENTS
ARE PRACTICED FOR COMPENSATION ON DISCOVERED
RESOURCES AND DISCOVERY OF GAS CAVERNS SHOULD NOT
