After reviewing the interrogatory sent by e-mail on June 7th, 2017, I had an opportunity to review the application and evidence sent to the Ontario Energy Board. It looks like 'X' was erroneously marked for both gas and electricity applications under Intended Services and Markets section:

- to sell or offer to sell electricity to low-volume consumers (annually consuming less than 150 ,000 kwh of electricity) in Ontario
- to sell or offer to sell electricity to large-voume sonsumers (annually consuming more than 150,000 kilowatt hours of electricity) in Ontario
- to sell or offer to sell gas to low-volume consumers(consuming 50,000 m3 or less of natural has per year) in Ontario
