**Re: EB-2016-0137/138/139 – Southern Bruce Expansion – Cost Claim**

We are counsel for the School Energy Coalition (“SEC”). Enclosed, please find SEC’s cost claim in this matter, on the Board’s form and including docket details. As outlined in detail on p.1 of the Decision and Order, the proceeding had a number of twists and turns as it started as a unique Franchise Certificate application filed by, at the time, a new entrant in Ontario, and then became the first competitive application under the Board’s new Community Expansion framework as set out in its Decision in EB-2016-0004.

SEC notes a few aspects of our cost claim.

First, in Procedural Order No. 3, the Board determined that it would limit the number of hours claimed for providing submissions in phase one to a maximum of 8 hours. SEC incurred more than the allotted time (15.2 hours) in providing detailed responses to the questions posed by the Board and comments on the draft filing requirements. We ask the Board to exercise its discretion and award our full time spent on this important activity. We believe that our submissions provided value to the Board commensurate with the time incurred. For ease, we have included time for this activity under the ‘Argument’ category on the cost claim form.

Second, in Procedural Order No. 9, the Board stated that it does not anticipate awarding costs for proposed interrogatories or submissions made by intervenors on the proposals. While SEC did file a proposed interrogatory, we have not included our time in doing so in our claim.

Lastly, the activities during this proceeding that intervenors were eligible to claim time for did not easily conform to the Board’s categories in the cost claim form. We have included our time for non-phase 1 submissions docket time in the ‘Other Conferences – Preparation’ category.
