3. To make a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at the offices of Hydro One Networks Inc. and Orillia Power Distribution Corp.
4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 and 2 above immediately thereafter.
5. To provide a copy of both the English and French versions of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.
