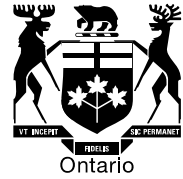

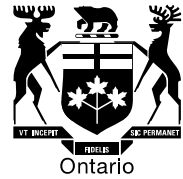

IN THE MATTER OF the *Ontario Energy Board Act 1998*,
S.O. 1998, c.15, (Schedule B);

AND IN THE MATTER OF an Application by Union Gas Limited for an Order pursuant to Section 90(1) of the Ontario Energy Board Act, 1998, granting leave to construct a natural gas pipeline and ancillary facilities in the Town of Puslinch, in the County of Wellington.

PROCEDURAL ORDER NO. 1

Union Gas Limited ("Union" or "the Applicant") has filed an application with the Ontario Energy Board (the "Board"), received on November 13, 2008, under section 90(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B).

Union has applied for an order of the Board for leave to construct approximately five kilometers of 12 inch Nominal Size Pipe ("NPS") pipeline intended to transmit additional volumes of gas for the purpose of increasing the capacity of the existing Guelph System to accommodate forecasted growth on the system. The proposed facilities are located in the Township of Puslinch, in the County of Wellington. The Board has assigned File No. EB-2008-0364 to this Application.

Notice of Application for the Leave to Construct Application was served and published as directed by the Board.

As a result of a Notice of Application being published, Enbridge Gas Distribution Inc. ("EGD") requested intervenor status and indicated it will not be seeking an award of costs. Subject to Union's right to object, the Board grants the intervention request to EGD.

The Board has determined that it is necessary to make the following provisions related to this proceeding:

THE BOARD ORDERS THAT:

1. Intervenors and Board Staff who wish information and material from the Applicant that is in addition to the evidence filed with the Board shall request it by written interrogatories filed with the Board, and delivered to the Applicant on or before, February 6, 2009.
2. All interrogatories and responses must include a reference to the section of the application which identifies the specific evidence on which the interrogatory is based.
3. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Intervenors no later than February 13, 2009.
