LETTER OF DIRECTION

Dear Ms. Wong:

**Re: Union Gas Application for Leave to sell 11.7 km Natural Gas Pipeline to a limited partnership being created between Spectra Energy Corp and DTE Pipeline Company
Board File No. EB-2008-0411**

The Board issued its Notice of Application and Hearing (the "Notice") with respect to the above case.

Union Gas Limited ("Union Gas") is directed:

1. To conduct a search of title, sufficient to determine the current registered property owners and encumbrancers of lands affected by the proposed sale of the 11.7 kilometer gas pipeline and to provide a list of the land owners and encumbrancers to the Board.
2. To immediately serve a copy of the Notice, together with a copy of the application, either personally, by courier or by registered mail, upon:
 - a) all property owners and encumbrancers of lands or interest in lands identified in the search of title referred to in paragraph 1 of this Letter of Direction;
 - b) all utilities and railway companies whose property will be affected by the proposed sale of the 11.7 kilometers gas pipeline;
 - c) all Municipalities, Townships, and Counties through which the existing 11.7 km of gas pipeline passes;
 - d) all Aboriginal Groups that could be affected by the project.
 - e) the additional persons listed in Appendix A to this Letter of Direction.

3. Union Gas is directed to immediately have the Notice published, headed with the Ontario Government logo and the words "Ontario Energy Board" in one issue of the "Sarnia Observer" which is a daily English newspaper in the City of Sarnia. Union Gas is directed to insert the map identified as Schedule A in the Notice.
4. To file with the Board an affidavit of service confirming service to the parties pursuant to paragraph 2 of this letter of direction; This affidavit of service must confirm that:
 - a) the property owners and encumbrancers of land served are all the property owners and encumbrancers affected by the proposed sale of the 11.7 kilometers pipeline;
 - b) the utilities and railway companies served are all utilities and railway companies whose lines would be crossed by the proposed sale of the 11.7 kilometers gas pipeline,
 - c) the Municipal, Township and County Clerks served are the Clerks of all affected Municipalities, Townships and Counties through which the existing 11.7 km of gas pipeline passes;
 - d) the Aboriginal Groups served are all of the Aboriginal Groups affected,.
 - e) the additional persons served are all the additional persons listed in Appendix A to this Letter of Direction.

Please ensure that the original post office registration receipts (where applicable) are attached as appendices;

5. To file with the Board a second affidavit of service confirming publication pursuant to paragraph 3 of this letter of direction with the Notice, application, and original post office registration receipts (where applicable) attached as appendices. It is not necessary that the affidavit of publication have the newspaper tearsheets attached.
6. To provide a copy of the application immediately to any person upon request.
7. To supply Union Gas' pre-filed evidence immediately to any person requesting it in a letter of intervention.
