

NOTICE OF APPLICATION AND HEARING

Application by Enersource Hydro Mississauga and Halton Hills Hydro Inc. for a Licence Amendment and Sale of Distribution Assets

The Application

Enersource Hydro Mississauga ("Enersource Hydro") and Halton Hills Hydro Inc. ("Halton Hills Hydro") have filed a joint application with the Ontario Energy Board under section 74 of the *Ontario Energy Board Act, 1998*, for an order of the Board:

- (a) amending the distribution service area of Halton Hills Hydro to reflect the transfer of 2 customers from Enersource Hydro to Halton Hills Hydro to eliminate the long term load transfer ("LTLT") arrangement between the two distributors; and
- (b) approving the sale from Enersource Hydro to Halton Hills Hydro of distribution assets necessary in serving the public to facilitate the transfer of the 2 customers proposed to be transferred from Enersource Hydro to Halton Hills Hydro through the service area amendment.

The Board assigned file number EB-2009-0041 to the application.

Section 6.5.4 of the Distribution System Code

Section 6.5.4 of the Distribution System Code ("DSC") deals with LTLT arrangements. A load transfer is a situation in which a customer is located in the licensed service area of one distributor (the "geographic distributor") but is physically served electricity by another distributor (the "physical distributor"). Section 6.5.4 of the DSC requires geographic distributors to eliminate their LTLT arrangements before January 31, 2009. This can be accomplished by either negotiating the transfer of the customers to the physical distributor or by the geographic distributor extending its system to connect the customers.

Service Area Amendment

According to the application, the service area amendment is being sought in order to eliminate the LTLT arrangement between Enersource Hydro and Halton Hills Hydro through the transfer of the customers to the physical distributor. The applicants state that since the physical distributor has the existing facilities and is already serving the customers, it would not be cost effective for the geographic distributor to incur significant capital costs to build duplicate facilities, nor would it be sensible for the affected customers to bear these capital costs.

The proposed service area amendment will expand Halton Hills Hydro's service area to include 2 customers who are currently within Enersource Hydro's service area but are physically supplied by Halton Hills Hydro. Presently, the customers are considered Enersource Hydro customers and are being charged Enersource Hydro's rates. The proposed amendments, if granted, will result in these customers becoming customers of Halton Hills Hydro and being subject to higher distribution rates.

The 2 customers are located on Winston Churchill Blvd, between Hwy 401 and Meadowpine Blvd with the civic address number 7575.

Sale of Distribution Assets

Enersource Hydro is seeking approval to sell certain assets that are part of its distribution system to Halton Hills Hydro for the net book value of the assets. The assets will continue to be used to serve the same customers presently served by the assets.

According to the application, the proposed sale of the distribution assets facilitates the elimination of the LTLT arrangements between Enersource Hydro and Halton Hills Hydro.

Your electricity distributor, Enersource Hydro Mississauga Inc. ("Enersource") and Halton Hills Hydro Inc. ("Halton Hills") filed a joint application with the Ontario Energy Board requesting changes to their electricity distribution service areas. If the application is approved, you will become a customer of Halton Hills. You are not required to take any action in response to this letter but you may wish to let the Ontario Energy Board know of any concerns you may have about the application.

As you know, you are currently a customer of Enersource and you are charged Enersource's rates for electricity distribution services. However, you may not know that your electricity is physically supplied by Halton Hills. You are within Enersource's service area but are actually served electricity by Halton Hills. This arrangement is known as a long term load transfer.

The Ontario Energy Board requires geographic electricity distributors (in your case, Enersource) to eliminate long term load transfer arrangements before January 31, 2009. One option available to distributors to meet this requirement is to permanently transfer the load transfer customers to the electricity distributor that physically supplies them (in your case, Halton Hills).

To eliminate the load transfer arrangements between Enersource and Halton Hills, both distributors filed a joint application with the Ontario Energy Board for an order approving changes to their distribution service areas in order to transfer you and similar load transfer customers to Halton Hills's service area. If the Board approves the application, you will become a customer of Halton Hills; you will be supplied and served by Halton Hills and will be charged Halton Hills's distribution rates which are higher than Enersource's distribution rates.

Based on your prior year's consumption, the proposed transfer will result in an estimated increase of \$9.28 on the delivery portion of your monthly electricity bill. This represents an impact of approximately 2.4% of the total bill.





To eliminate the load transfer arrangements between Enersource and Halton Hills, both distributors filed a joint application with the Ontario Energy Board for an order approving changes to their distribution service areas in order to transfer you and similar load transfer customers to Halton Hills's service area. If the Board approves the application, you will become a customer of Halton Hills; you will be supplied and served by Halton Hills and will be charged Halton Hills's distribution rates which are higher than Enersource's distribution rates.

Based on your prior year's consumption, the proposed transfer will result in an estimated increase of \$10.83 on the delivery portion of your monthly electricity bill. This represents an impact of approximately 3.5% of the total bill.

An official Notice of Application was issued by the Board, a copy of which is attached to this letter. The Notice contains information about how to participate in the proceeding associated with the application.
