S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Hydro One  
Remote Communities Inc. for an order approving just and  
reasonable rates and other charges for electricity distribution  
to be effective May 1, 2009.

### **PROCEDURAL ORDER No. 2**

Hydro One Remote Communities Inc. ("Remotes") filed an application with the Ontario Energy Board (the "Board") on August 29, 2008 under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to the rates that Remotes charges for electricity distribution, to be effective May 1, 2009. The Board assigned File Number EB-2008-0232 to this application.

The Board issued a Notice of Application and Hearing on September 23, 2008. Procedural Order No. 1, was issued on November 11, 2008. The Board made provision for written interrogatories.

The Board has determined that it has sufficient information to proceed directly to submissions and that final arguments from all parties are to be filed as described below.

Please be aware that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

### **THE BOARD ORDERS THAT:**

1. If Board staff wishes to make a written submission on the application, Board staff must file that submission with the Board, and deliver it to Remotes' and other intervenors by March 5, 2009.

2. Intervenor who wish to make a written submission on the application must file that submission with the Board, and deliver it to Remotes' and other intervenors by March 12, 2009.
3. If Remotes' wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors no later than March 19, 2009.

All filings to the Board must quote file number EB-2008-0232, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca). If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
