**IN THE MATTER OF** the *Ontario Energy Board Act*,  
1998, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Oshawa  
PUC Networks Inc. for an order or orders approving just  
and reasonable rates and other charges for electricity  
distribution to be effective May 1, 2009.

### **PROCEDURAL ORDER No.3**

Oshawa PUC Networks Inc. ("Oshawa") filed an application with the Ontario Energy Board, received on November 7, 2008, under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that Oshawa PUC Networks Inc. charges for electricity distribution, to be effective May 1, 2009. The Board has assigned the application file number EB-2008-0205. The Board issued a Notice of Application and Hearing dated November 27, 2008, in which it announced that the application would be reviewed in two parts: Part I is the review of the standard IRM application and requests regarding recovery of Lost Revenue Adjustment Mechanism (LRAM) and Shared Savings Mechanism (SSM) amounts. Part II is the review of the request for incremental capital investment. This Procedural Order only relates to Part II of the application.

On January 7, 2009, the Board issued Procedural Order No. 1 in which it made provision for written interrogatories on Part II of the application. On March 5, 2009, the Board issued Procedural Order No. 2 in which it determined that there would be benefit from proceeding with an oral hearing for Part II of the application. The Board ordered that the oral hearing would be convened on March 23, 2009. On March 10, 2009, Oshawa informed the Board that it would not be able to produce a witness panel on March 23, 2009, and requested that the oral hearing be rescheduled to a later date.

The Board will grant Oshawa's request to reschedule the oral hearing on Part II of this proceeding.

Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

**THE BOARD ORDERS THAT:**

1. The oral hearing is rescheduled and will be convened starting at 9:30 a.m. on Monday **April 6, 2009**, at the Board's offices at 2300 Yonge Street on the 25<sup>th</sup> floor. In the event more time is required for the hearing, the oral hearing will resume on **April 7, 2009**.

All filings to the Board must quote file number EB-2008-0205, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available you may e-mail your document to the address below.
