I am writing as counsel for Union Gas Limited (Union) to provide Union's submissions in support of its application EB-2008-0405.



Further to our earlier correspondence, Union Gas Limited is proposing to create a Designated Storage Unit for the purposes of storing Natural Gas in the area of Highway 40, Sombra Township, Lot 6 Concession 15.
