The Board has now issued its Notice of Application (the “Notice”) with respect to the above noted application (the “Application”).

You are directed:

- 1) To arrange immediately for the enclosed English version of the Notice, headed with the Ontario government logo and the words “Ontario Energy Board”, to be published in the English language newspapers having the highest paid circulation, according to the best information available, in Toronto Hydro-Electric System Limited’s service areas;
- 2) To arrange immediately for the enclosed French version of the Notice headed with the Ontario government logo and the words “Commission de l'énergie de l'Ontario”, to be published in the French language newspapers having the highest paid circulation, according to the best information available, in Toronto Hydro-Electric System Limited’s service areas, as applicable;

Please note that invoices regarding publication are not to be sent to the Board.

- 3) To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on intervenors of record for Toronto Hydro-Electric System Limited's last distribution rates proceeding;
- 4) To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter.
 - a. The affidavit must be sworn by a commissioner of oaths which include, among others, a lawyer, a paralegal, some law clerks, and a student at law;
 - b. A copy of the notice of publication (i.e., the Notice published in the newspapers) should also be added as an exhibit;
 - c. A copy of the registered mail receipt(s) or courier slip(s) for the Notice served to the embedded distributors should be added as an exhibit.
- 5) To make a copy of the application and evidence, and any amendments thereto, available for public review on Toronto Hydro-Electric System Limited's website and at its offices in Toronto; and,
- 6) To provide a copy of the application and evidence, and any amendments thereto, to any person who requests a copy.
