Intervenor Status Request**

By way of this letter, PUC Distribution Inc. is requesting intervenor status with respect to applications from Great Lakes Power Limited ("GLPL"), Great Lakes Power Distribution Inc. ("GLPD"), and Great Lakes Power Transmission LP ("GLPTLP"), application numbers EB-2009-0072, EB-2009-0073 and EB-2009-0075. The applications were filed with the Ontario Energy Board dated March 6, 2009 under sections 18, 60, 74, 77(5) and 86(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B (the "OEB Act").

PUC Distribution Inc. ("PUC") is a licensed distributor of electricity (ED-2002-0546) providing service within its licensed service area consisting of the City of Sault Ste. Marie (with the exception of all or part of five municipal addresses as listed on its distribution licence), Township of Prince, Rankin Reserve, and the Township of Dennis (concessions 3, 4 and 5). Great Lakes Power Distribution is an adjacent electricity distributor and PUC has a Transmission Service Agreement with Great Lakes Power Transmission LP. PUC Distribution Inc. has an interest in regulatory proceedings that may impact the electricity service adequacy, reliability and safety.
