The Board has reviewed your application. Your application is currently incomplete and cannot be processed until the following has been filed:

- Section 2 – Licence Primary Contact requests that if the address for the primary contact is not in Ontario, the applicant must also provide contact information for service purposes in the province of Ontario. Given that Rainbow Energy Marketing Corporation's ("Rainbow Energy") offices are not located in Ontario, you may provide the address of an agent as the address of service.
- Section 8 – Corporation Organization requests that a description of the applicant's corporate organization and the applicant's relationship with its energy sector affiliates and associated entities be provided. Please provide a description of Rainbow Energy's corporate organization and its relationship with energy sector affiliates, if applicable.

- Section 9 – Finance requests that if the applicant does not submit financial statements for itself or its parent company, along with a parental guarantee, the applicant must file at least two of the following items:
 - Most recent prospectus and quarterly report
 - Proforma statements for two years if applicant is a new company. Documents must be signed by one key individual.
 - Letter of reference from the applicant's bank
 - Proof of meeting the prudential payments required in the IESO wholesale market

Your application states that Rainbow Energy has provided the IESO with a letter of credit for prudential support. Please provide a copy of the IESO's letter of credit for prudential support for Rainbow Energy, in addition to one additional item from the above list.

- Section 10 – Technical Resources requests that the applicant briefly describe the technical qualifications of at least one person employed by the applicant. Please provide specific details of Rick Sornberger's technical qualifications and experience.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.
