**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Oshawa PUC Networks Inc. for an order or orders approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2009.

## PROCEDURAL ORDER No. 4

Oshawa PUC Networks Inc. ("Oshawa") filed an application with the Ontario Energy Board, received on November 7, 2008, under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that Oshawa PUC Networks Inc. charges for electricity distribution, to be effective May 1, 2009. The Board has assigned the application file number EB-2008-0205. The Board issued a Notice of Application and Hearing dated November 27, 2008, in which it announced that the application would be reviewed in two parts: Part I is the review of the standard IRM application and requests regarding recovery of Lost Revenue Adjustment Mechanism (LRAM) and Shared Savings Mechanism (SSM) amounts. Part II is the review of the request for incremental capital investment. The Board issued its Decision on Part I of the application on March 20, 2009. This Procedural Order only relates to Part II of the application.

An oral hearing took place on April 6, 2009. At the conclusion of the hearing, the Board decided to wait until Oshawa filed its responses to certain undertakings before setting out dates for argument. Oshawa filed its responses to the undertakings on April 17, 2009.

Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

## THE BOARD ORDERS THAT:

1. Intervenors (including Board staff) that wish to make a submission on the Part II of the application must file their submissions with the Board, and deliver it to the applicant by Monday **May 4, 2009**.

2. Reply submissions by the applicant must be filed with the Board and delivered to the intervenors by Monday **May 11, 2009**.

All filings to the Board must quote file number EB-2008-0205, be made through the Board's web portal at <a href="www.errr.oeb.gov.on.ca">www.errr.oeb.gov.on.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available you may e-mail your document to the address below.
