

Notice of Application And Notice of Written Hearing

Electricity Wholesaler Licence – Rainbow Energy Marketing Corporation EB-2009-0115

Rainbow Energy Marketing Corporation ("Rainbow Energy") has applied to the Ontario Energy Board for renewal of its electricity wholesaler licence. The granting of this licence would enable the applicant to purchase and sell electricity in Ontario. The Board has assigned file number EB-2009-0115 to the application.

The application will be decided by the Counsel, Special Projects who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The Counsel, Special Projects does not intend to provide for an award of costs when deciding this application.

How to participate in the hearing

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing for this application, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by May 25, 2009.

If you wish to participate in a written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submission to the Board and one copy to the applicant. All submissions must be received by May 29, 2009. If the applicant wishes to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions by June 5, 2009.

All submissions must quote file number EB-2009-0115 and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All

communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
