# Response to Interrogatory from Board Staff

### 1) Projected Load Increases

Reference: Pre-filed Evidence Schedule 3

#### Preamble:

In Schedule 3, a construction/gas connection forecast is provided for the service area in question and as a consequence of this forecast, Union states there will be a requirement for more than 400 new connections (mostly residential single and multi-family dwellings) between 2009 and the end of 2018.

# **Questions:**

- a) On a year over year basis, what does Union project the load increase to be in percentage terms on both a peak demand and volumetric usage basis between 2009 and 2018?
- b) Given that Union utilizes this particular planning protocol on a regular basis to project future gas usage and demand requirements, how accurate has this protocol proven to be in the past and if inaccuracies have occurred how has Union taken these inaccuracies into consideration in its current planning process (e.g. has the current economic downturn been factored into the process)?

b) Union has been completing FBPs for distribution projects for over 10 years. When comparing the customer forecast prepared for Guelph Reinforcement Phase I (EB-2004-0205) to the actual customer attachments identified in Guelph Reinforcement Phase II (EB-2008-0364), it can be noted that Union's growth projections had an accuracy of 98%. Based on this accuracy, Union believes we have a very good understanding on projected growth in the Guelph area. Union has long standing history of using these methods which have proven successful.

Union's FBP forecasting methodology involves the assessment of the FBP area by our District growth and development representatives. The representatives, using local market knowledge and in consultation with local planning agencies, developers and officials, develop the forecast to support the FBP process. This method was chosen to provide adequate detail while at the same time being reasonable in its approach to forecasting and updating.

Union has refined this methodology based on historical success, market forecasting tools, availability of municipal planning documentation and best practices. This approach has been used by Union for greater than 10 years.

Union is not aware of any alternative growth forecast studies and as such, none have been provided.

In terms of the current economic downturn referenced in the IR, the actual peak hourly flow of the Kingston Township natural gas system increased from the 2007/08 winter to the 2008/09 winter. This reinforcement project remains a requirement for the 2009/10 winter. In addition, the applied for reinforcement project is being constructed for the long term health of the Kingston Township natural gas system. Based on these reasons, no adjustments were made to the original load forecast.

Receipt is acknowledged of your letter dated February 26, 2009 together with the Environmental Study Report for the above noted project. In reviewing the document, I would note the following:

In the Executive Summary on page ii, there is a reference at the bottom of the page to the Cataraqui East Secondary Plan. That should read Cataraqui West Secondary Plan.

On page 10, under the discussion of Land Use Planning (3.4.3), it should be noted that the policies of the former Township of Kingston are still applicable as the municipality has not yet adopted its new consolidated Official Plan. In addition, a more recent Fall 2008 Draft was released for public comment. Formal consultation on the Draft Official Plan is scheduled for June, 2009.

A copy of the Stage I Archaeological Study should be forwarded to the City's Heritage Planner (Marcus Letourneau – mletourneau@cityofkingston.ca) for his review and comment. Also, please advise whether or not the Ministry has accepted the consultant's Stage I report and if so, please provide a copy of the Ministry letter. The Stage II report should also be submitted to the City's Heritage Planner.

Thank you for the opportunity to review the report. Should we have any further comments from a Planning & Development perspective, we will advise accordingly.

We have discussed your request to commence brushing along Creekford Road as it relates to the alignment of the gas main construction that we reviewed in the field on Thursday April 23, 2009 and can confirm that in principal the alignment is satisfactory to the City of Kingston. This is provided recognizing that the City will have the opportunity to review the design drawings and request alignment changes in the event that additional information is found during the preparation of the final construction drawings before and final approval is provided to Union Gas.

We have confirmed that there have been advance discussions with our Forestry Division, in particular with Eugene Conners, confirming the brushing activities and identifying the extent of the works required. The following is provided in response to a letter from Union Gas to the Ministry of Transportation (MTO), dated March 30, 2009, which contained a copy of **Ontario Energy Board, Notice of Application EB-2009-0061**.

At this time, MTO is also in receipt of an Environmental Study Report (ESR), for the Creekford Road Reinforcement Project, prepared for UnionGas, by Azimuth Environmental Consulting Inc., dated Feb 2009.

The Union Gas project, scheduled to commence Summer 2009, is of concern to MTO as the gas line alignment goes through the Gardiners Road / Creekford Road (Centennial Drive) intersection. Although the ESR implies the work is on the south side of the intersection, which is not physically on MTO property, the work is within the MTO Building and Land Use Permit control area. The proposed utility installation may have impacts upon traffic operations during construction, and may also have impacts to the existing and future intersection plans. Union gas should be aware that there is a traffic signal plant and illumination in that area. Additionally, The City of Kingston has future plans to widen Centennial Drive (opposite Creekford Road), as per the Robinson Industrial Park traffic study. As such, MTO requests that a copy of the engineering drawings for the Creekford Road Reinforcement project, be provided to MTO for review and comment.

Please note that, under the authority of the Public Transportation and Highway Improvement Act R.S.O. 1990, MTO, through the issuance of permits controls all land use within 45 meters (150 feet) of the ministry's property limit, and within 395 meters (1300 feet) of the center points of the Highway 401 / Gardiners Road Interchange. Development within these limits is subject to MTO Building and Land Use Permit control. Permits are required prior to the commencement of construction and are available from Lina Arsenault, at the contact numbers below.

By means of this letter, MTO requests that Union Gas provide the requested engineering documentation to Lina Arsenault, and that OEB provide all future information regarding **Ontario Energy Board, Notice of Application EB-2009-0061** to Lina Arsenault, Corridor Management Officer, at The Ministry of Transportation, Ottawa Area Office, 347 Preston Street, 4<sup>th</sup> Floor, Ottawa, Ontario K1S 3J4

Thank you for your February 26, 2009 letters to Penny Stewart and me, and copies of the Environmental Study Report prepared by Azimuth Environmental Consulting Inc. and dated February 2009. We have no objections to the project, but have comments about the potential need for Permits to Take Water for construction activities in addition to hydrostatic testing.


The project involves constructing a 6 inch natural gas pipeline within the road allowances along Creekford Road and Gardiners Road. The pipeline will extend from an existing Union Gas pipeline near the west end of Creekford Road to a new tie-in location at the intersection of Gardiners Road and Fortune Crescent.

### Mitigation, Restoration and Monitoring

The report commits to mitigation and restoration measures in accordance with the Ontario Energy Board Environmental Guidelines for Locating, Constructing and Operating Hydrocarbon Pipelines in Ontario, 2003, the Union Gas Environmental Management Manual, and the Union Gas Erosion and Sedimentation Control Standards. The two Union Gas guidelines are included in the appendices to the report. In addition, the report states that a Land Relations Agent will be available to assist in maintaining good relations with homeowners throughout construction, and that an Environmental Inspector should be assigned to the project throughout the construction period to ensure that impacts are mitigated and restoration measures are carried out.

The report commits to mitigation measures such as:

- pre-blast surveys and receptor blast monitoring;
- landowner notification prior to blasting;
- control of noise, dust and flyrock during blasting;



- implementing the standard Union Gas well monitoring program that involves retaining the services of a qualified hydrogeologist to determine an appropriate well monitoring program where necessary;
- providing water supplies where wells are impacted by construction;
- contacting MNR, DFO and the CRCA to obtain approval of the watercourse crossing method (Collins Creek);
- use of energy dissipater systems for discharge of hydrostatic testing discharge, and allowing chlorine to dissipate prior to discharge to a watercourse;
- managing contaminated soil in accordance with the *Environmental Protection Act* and Regulation 347;
- spill containment, clean-up and reporting;
- adherence to local noise by-laws;
- use of mufflers on construction vehicles; and
- dust control using water.

MOE staff concur with the mitigation and monitoring measures proposed above.

### Permit to Take Water

Permits to Take Water (PTTW), issued under section 34 of the *Ontario Water Resources Act*, are required for any taking, dewatering, storage or diversion of water in excess of 50,000 litres per day. Activities which may require Permits to Take Water include hydrostatic testing, dewatering behind a coffer dam, diversion of stream flow to allow work in the dry at a water crossing, construction dewatering, and use of water to make up a drilling slurry.

The report recognizes the need for a PTTW for hydrostatic testing when volumes exceed 50,000 litres per day, but does not discuss the need for a PTTW for other construction activities such as during water crossings. For example, the report states that water crossings are proposed to be constructed using either a directional drill technique or a dam and pump technique. Either of these techniques could result in diversion or taking of water.

Our office has had the opportunity to review the Creekford Road Reinforcement Project Environmental Study Report (ESR). Based on our review of the information we have no additional comments with respect to either of the proposed methods of crossing indicated below.

We recognize that the Conservation Authority has been contacted in order to obtain a permit. We trust that timing windows (no in water works between April 1st and June 30th) and mitigation related to fisheries (i.e. sedimentation and erosion control methods) and post-construction replanting of native vegetation will be addressed through the Conservation Authority permitting process.

Based on the information within the ESR it is our understanding that no species at risk were observed during any field visits. Should any species at risk be observed and potentially affected by on site activities, Peterborough District MNR should be contacted immediately and operations should be modified to avoid any negative impacts to species at risk or their habitat until further direction is provided by our office.

### 4) Comparison of Alternatives

Reference: Pre-filed Evidence Schedule 8, pages 8-11

### Preamble

In Schedule 8, Section 3.5 Union compares various alternatives as follows:

- The P.I. of this reinforcement was less favourable than the other alternatives (3.5.1 Joining Two Independent Systems)
- This Reinforcement alternative was rejected due to the fact that the routing of the pipeline was not preferred (3.5.3 Reinforcement from an Alternate Route)
- This alternative provides additional system integrity benefits (3.5.4–Reinforcement with a Second Feed)

# Questions

- a) What was the P.I. for Alternative 3.5.1?
- b) Please explain why the routing for alternative for Alternative 3.5.3 was considered undesirable?
- c) What were the additional system integrity benefits anticipated for Alternative 3.5.4?

### **Response:**

- a) The PI for alternative 3.5.1 is 1.06.
- b) The routing for alternative 3.5.3 is considered undesirable for the following reasons:
  - 1. Involves a 401 crossing (rock bore);
  - 2. Construction Conditions are rock
- c) The additional system integrity benefit for alternative 3.5.4 is the added ability to supply gas to the existing high pressure network during an outage scenario at either the Woodbine TBS or main high pressure supply network. The result of having an additional TBS and an additional gas supply into the existing high pressure network will provide additional system integrity during non-peak hourly flow conditions.

In its letter of April 8 2008, the MTO expressed concerns regarding the proposed routing of the pipeline for the proposed project in the vicinity of the Creekford Road/Gardiners Road intersection.

# **Question:**

a) When does Union anticipate sending drawings and engineering documentation regarding its proposals for the Creekford Road/Gardiners Road intersection to the MTO (both the Ottawa and Kingston MTO Offices)?

### **Response:**

An application for an encroachment permit, accompanied by drawings showing details of the proposed work were sent to Lina Arsenault of the MTO on May 25<sup>th</sup>, 2009 per a letter from the MTO to the Board.

Union followed up with Mrs. Arsenault June 8<sup>th</sup> and at her request; an application for a "Building and Land Use Permit" was submitted to her on that same June 8<sup>th</sup>. She had indicated that all documentation was satisfactory at this time and that once the review had been completed, a permit would be issued.

a) Please confirm that if there is a requirement to bring water to the site for hydrostatic testing (inadequate flow from Collins Creek), that the water will be of similar or higher quality than that in the receiving watercourse and if chlorinated water is used for testing then the chlorine be allowed to dissipate before it is released into the receiving watercourse as noted on page 28 of the Azimuth Environmental Review Report.

In the Environmental Review Report, Azimuth makes reference to possible soil contamination along the proposed route near Gardiners Road

## **Question/Request**

a) Please detail the soil and groundwater management program that will be used by Union if there is contaminated soil found near the auto wreaking yard that is located on Creekford Road near Gardiners Road

### **Response:**

a) As indicated in ER, page 28, section 7.2.6, Union obtained the services of Golder Associates (Golder) to perform geotechnical and geo-environmental investigations near the wrecking yard within the road allowance of Creekford Road. The investigations indicated that there were no indications of soil or groundwater contamination near the wrecking yard on Creekford Road. As a result of the investigations findings, Union is not anticipating encountering contaminated soils or water.

- b) i) The Aboriginal contacts were provided by Union Gas and in consultation with Indian and Northern Affairs Canada.
  - ii) Azimuth contacted Indian and Northern Affairs Canada to obtain their input on potential First Nations issues and the appropriate First Nations contact. Contact was first initiated by written correspondence September 2008 when Notification was sent to the government agencies, adjacent property owners and First Nations informing them of the project and requesting any information or concerns they may have that should be considered in the selection of alternative routes.
  - iii) Chief Don Maracle, The Mohawks of Quinte and Chief James Marsden, Alderville First Nation
  - (iv) No response was received from the groups. Additional letters were sent in October 2008 inviting the groups to a Public Information Session and in February 2009 with a copy of the Environmental Study Report (Letters Attached). No response was received, and no attendance was made by the groups regarding this project. Union Gas did attempt to contact the groups by phone on April 14, 2009 and left messages with no response.
- c) No information was provided by the Mohawks of Quinte or by Alderville First Nation regarding their treaty rights, or any filed and outstanding claims or litigation concerning their treaty rights or treaty land entitlement or aboriginal title or rights, which may potentially be impacted by the project. The Status of Claims in Southern Ontario mapping from the Specific Claims Branch of Indian and Northern Affairs Canada web site, data as of 2009/06/09, showed no claim in the study area.
- d) Copies of letters sent to the Mohawks of Quinte and to Alderville First Nation are the same as that sent to the government agencies and are appended in the Environmental Report. No written information, phone calls or request for a meeting was received from the Mohawks of Quinte or by Alderville First Nation.
- e) No specific issues or concerns were raised.

- g) No response in either support of, or in objection to, the project was provided.
- h) We are not aware of any Crown involvement with the Mohawks of Quinte or by Alderville First Nation for this project.
