FortisOntario, which is headquartered in Fort Erie, Ontario, owns and operates generation, transmission and distribution businesses in the province of Ontario. Founded in 1892, FortisOntario began generating electricity in 1905 from its Rankine Generating Station located on the Canadian side of the Niagara River and subsequently began distributing electricity to the Town of Fort Erie in 1907. The Rankine Generating Station is no longer active and ceased operations in 2005. Most of FortisOntario's remaining generation assets were transferred to an affiliate as part of an internal reorganization described below. Accordingly, the operations based in Ontario that are part of the Canadian Niagara Power Inc. corporate organization are primarily transmission and distribution.

FortisOntario is the Ontario-based subsidiary of Fortis Inc. ("Fortis"), which is the largest investor-owned distribution utility in Canada. With total assets exceeding \$10 billion and annual revenues exceeding \$3.5 billion, Fortis serves almost 2,000,000 gas and electricity consumers. Its regulated holdings include a natural gas distribution utility in British Columbia and electric distribution utilities in five Canadian provinces and three Caribbean countries. Fortis owns non-regulated hydroelectric

generation assets in Newfoundland and Labrador, Ontario, British Columbia, Belize and Upper New York State. Fortis is a publicly traded company listed on the TSX.

FortisOntario also owns Cornwall Electric Railway Light and Power Company Limited ("Cornwall Electric"), which serves 23,000 customers. FortisOntario holds a ten percent (10%) interest in Westario Power Inc., a 21,000 customer electricity distributor located in mid-western Ontario, and Rideau St. Lawrence Holdings Inc., a 6,000 customer electricity distributor located in southeastern Ontario. Accordingly, Westario Power Inc. and Rideau St. Lawrence Holdings Inc. are not affiliates of CNPI.

FortisOntario is also a licensed generator. In addition to the retired Rankine Generating Station located in Niagara Falls, it owns a 5 MW natural gas cogeneration district heating plant located in Cornwall, Ontario. The Rankine Generating station is a Registered Market Participant with the IESO. The Cornwall district heating facility is an embedded generator selling district heating to local customers and electricity directly to Cornwall Electric.

Pursuant to Section 74 of the OEB Act, the Board was notified of an internal reorganization of Fortis in 2005, in respect of which it confirmed that it did not intend to issue a notice of review of the proposals (Board File No. EB-2005-0519). The corporate reorganization of certain Fortis energy companies was done to simplify management structure and to achieve tax planning objectives. This internal reorganization is completed and involved the transfer of FortisOntario Generation Corporation ("FOG"), previously a wholly-owned subsidiary of FortisOntario and a licensed generator, from FortisOntario to Fortis Properties Corporation ("FPC"), a wholly-owned subsidiary of Fortis. FOG owned and operated five (5) hydroelectric generating stations located on the Rideau Canal system in eastern Ontario with combined capacity of 5.6 MW (embedded generators for CNPI -Eastern Ontario Power), and one 2 MW hydroelectric generating station located at Rideau Falls in Ottawa. These stations are licensed generation facilities. Pursuant to amalgamations, FOG now forms part of FPC and continues as FPC.

The utility distribution business for the service areas of Fort Erie and Gananoque are owned by CNPI. The utility distribution assets for the service territory of Port Colborne are leased by CNPI from Port Colborne Hydro Inc., a wholly-owned subsidiary of the Corporation of the City of Port Colborne. This is a ten year operating lease approved by the Board (Appendix A). However, title to modified or contributed distribution assets is retained by CNPI in respect of assets for the Port Colborne service territory acquired subsequent to the commencement of the lease in April 2002. The utility distribution business for the Cornwall service area is owned by Cornwall Electric.

CNPI is also an OEB licenced transmitter.

Grimsby Power Inc.

Grimsby Power Inc. is a wholly owned subsidiary of the Town of Grimsby, providing electricity distribution services to electricity consumers located in the Town of Grimsby, as regulated by the OEB.

The Cornwall district heating facility is an embedded generator selling district heating to local customers and electricity directly to Cornwall Electric.

Canadian Niagara Power Inc. is a licenced distributor providing electricity distribution service to the Town of Fort Erie, the City of Port Colborne and the Town of Gananoque; more specially described in its Distribution Licence, ED-2002-0572.

Cornwall Electric is a licenced distributor providing electricity distribution service to the City of Cornwall; more specially described in its Distribution Licence, ED-2004-0405.

Canadian Niagara Power Inc. - Electricity Transmission Licence

Canadian Niagara Power Inc. is a licenced transmitter with transmission facilities interconnected with Hydro One Networks in Niagara Falls, Ontario and providing transmission service to Canadian Niagara Power Inc.'s

distribution facilities in Fort Erie and is interconnected with US National Grid in New York State. This is more specifically described in its Transmission Licence, ET-2003-0073

Grimsby Power Inc.

Grimsby Power Inc. is a licenced distributor providing electricity distribution service to the Town of Grimsby; more specially described in its Distribution Licence, ED-2002-0554.

FortisOntario generation associated with the Rankine Generating Station for 2007 was 653,496 MWh. This generation, 653,496 MWh, does not originate at the FortisOntario's Rankine generating station. By way of an agreement with Ontario Power Generation, water that would have otherwise been utilized at the Rankine Generating Station is allowed to flow to Ontario Power Generation's facilities and FortisOntario is compensated by an amount equivalent to that which is available at the Rankine Generating Station.

Therefore FortisOntario generation represents 0 % of the Annual Primary Demand of 152,205,120 MWh.

The FortisOntario water rights associated with the Rankine Generating Station are scheduled to expire on April 30, 2009.

Cornwall District Heating, a subsidiary of FortisOntario, is not connected to the IESO-Controlled Grid and therefore its production does not contribute to the Ontario Primary Demand.

1.5 Description of the Proposed Transaction or Project and Impact on Competition - General

1.5.1

Currently, Niagara Power Incorporated ("NPI") is the sole shareholder of Grimsby Power Incorporated ("GPI"). The sole shareholder of NPI is the Town of Grimsby. Both GPI and NPI currently have only common shares outstanding.

The effect of the transaction will be that FortisOntario Inc. will acquire a 10% economic interest in GPI through an investment in NPI preferred share The transaction will be effected by way of an amalgamation. FortisOntario will incorporate a new, wholly-owned subsidiary ("FO Subco") which it will capitalize with \$1.1 million. FO Subco will amalgamate with Niagara Power Incorporated ("NPI") to form "Amalco". In the amalgamation, the Town of Grimsby, NPI's sole shareholder will receive, in exchange for its shares of NPI 100%, of the common shares of Amalco plus 90 Class A Preferred Shares of Amalco. FortisOntario will receive, in exchange for its shares of FO Subco, 10 Class B Preferred Shares of Amalco.

The Class A and Class B Preferred Shares of Amalco (collectively the "Preferred Shares") will have identical rights and preferences. Generally, the Preferred Shares will entitle the holders thereof to the proceeds from any dividends or proceeds received by Amalco on the common shares of GPI, which is currently a wholly-owned subsidiary of NPI and will be a wholly owned subsidiary of Amalco. The Preferred Shares will also be redeemable by Amalco in exchange for a pro rata number of GPI common shares. For example, on redemption of the Preferred Shares, FortisOntario would receive 10% of GPI common shares and the Town of Grimsby would receive 90% of the GPI common shares. In effect, through the Preferred Shares, FortisOntario will have a 10% economic interest in GPI.

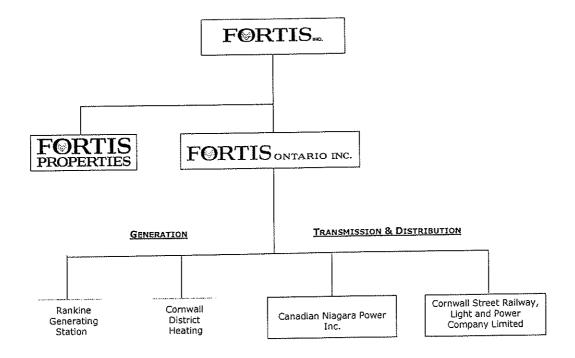

CORPORATE ENTITIES STRUCTURE OF GRIMSBY POWER INC.

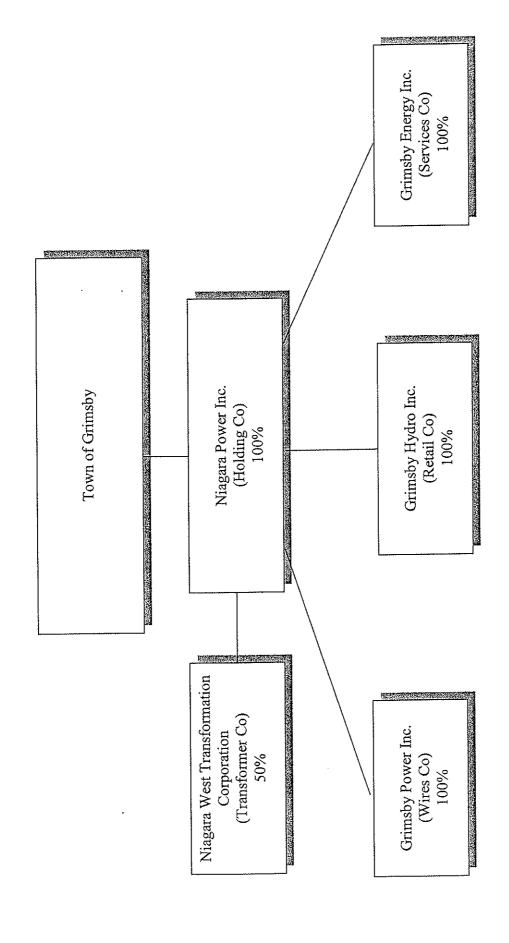
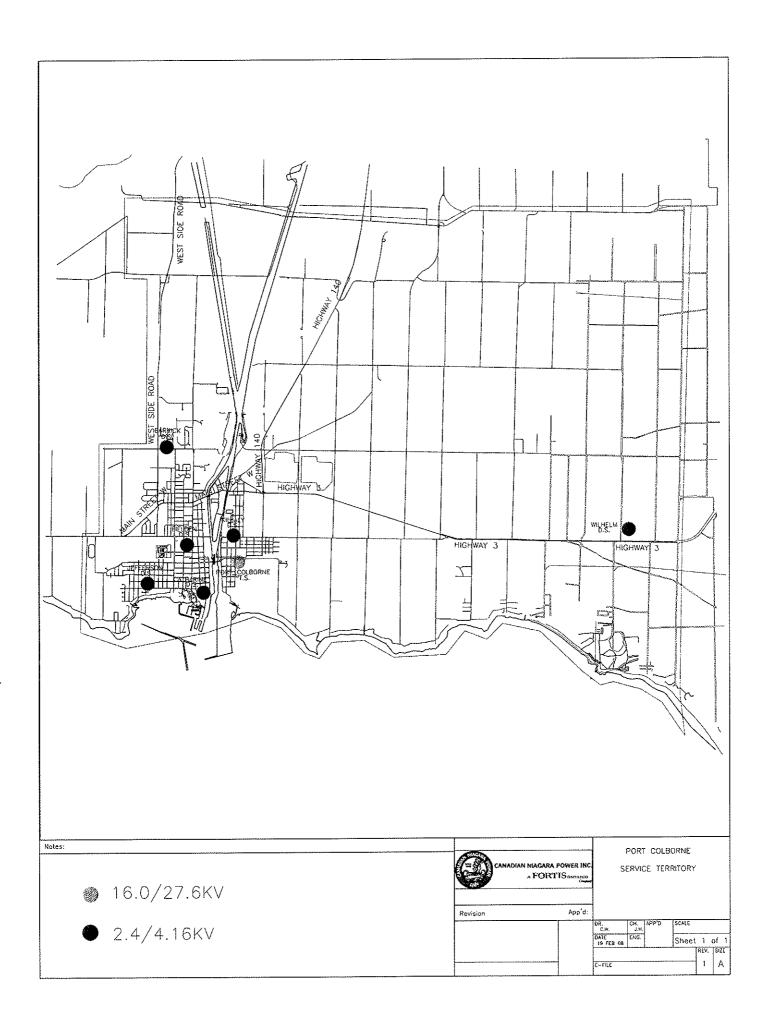


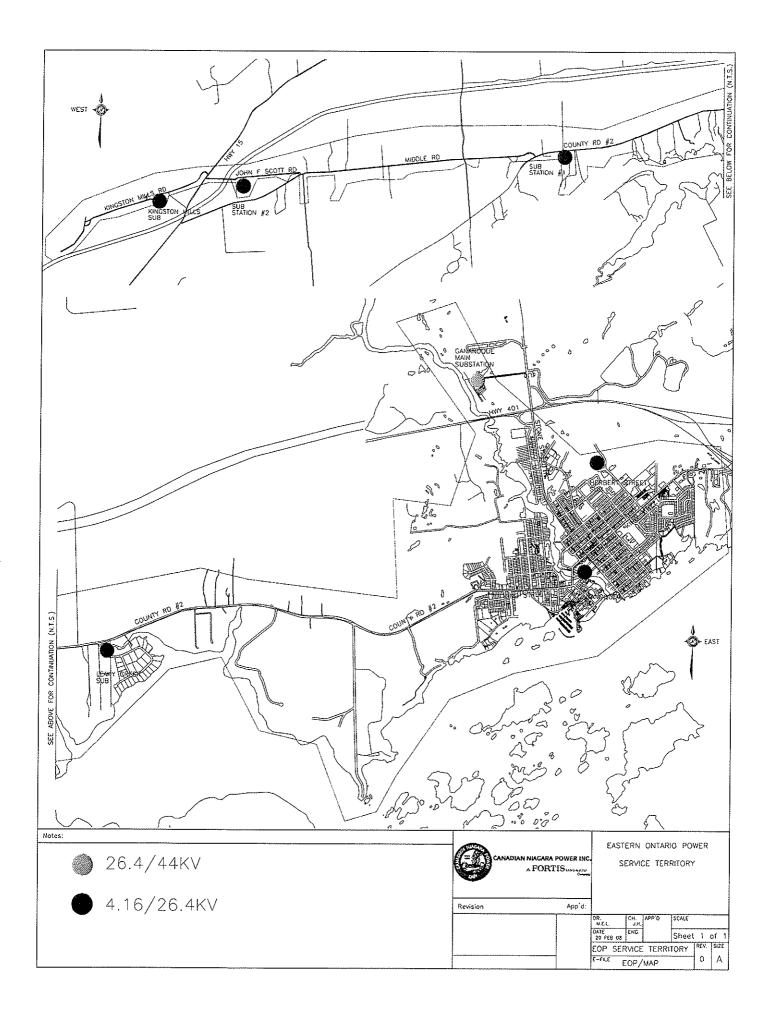

Eastern Ontario Power Service Area

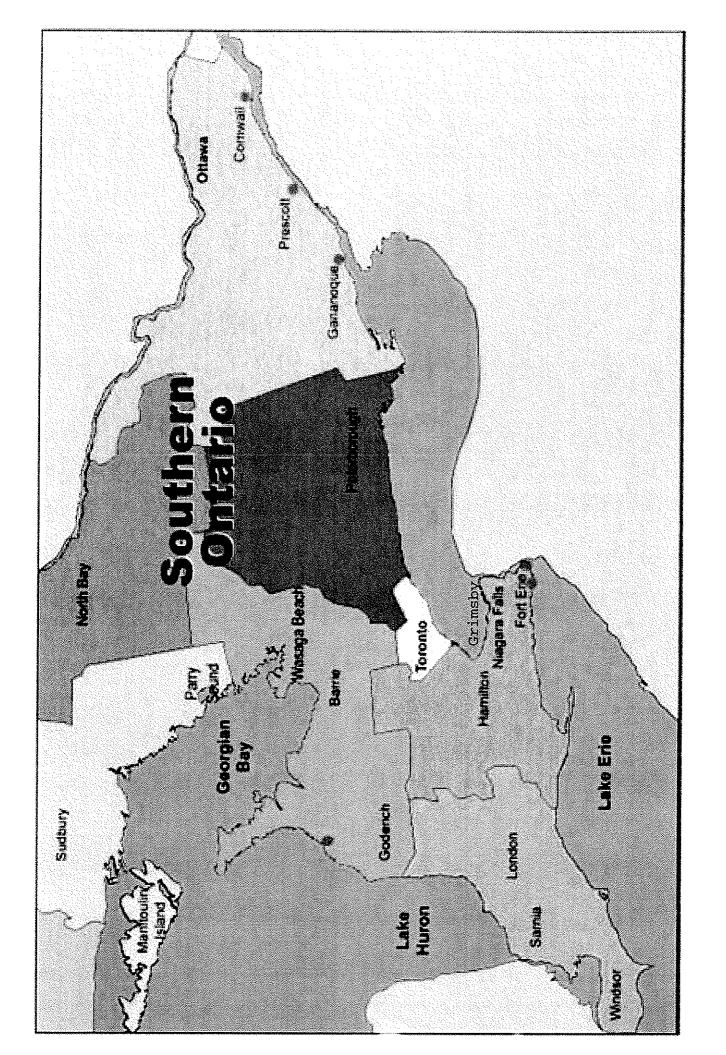


Fort Erie Service Area

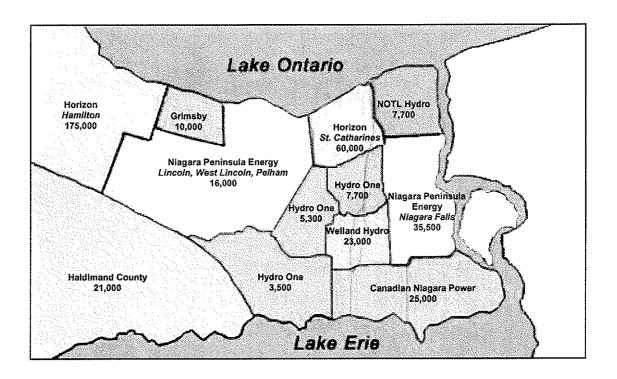
Map
