Gosfield Wind Limited Partnership is an affiliate of Great Lakes Power Limited and section 80 of the *Ontario Energy Board Act, 1998* applies.

Section 80 provides that,

“No transmitter or distributor or affiliate of a transmitter or distributor shall acquire an interest in a generation facility in Ontario, construct a generation facility in Ontario or purchase shares of a corporation that owns a generation facility in Ontario unless it has first given notice of its proposal to do so to the Board and the Board,

- a) has not issued a notice of review of the proposal within 60 days of the filing of the notice; or
- b) has approved the proposal under section 82.”

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
