PUBLIC CONSULTATION - AGENCY CONSULTATION

- 2 RES Canada has consulted with five federal government agencies, 13 provincial
- 3 government agencies, as well as the Municipality of Chatham-Kent and agencies within
- 4 the County of Chatham-Kent. Details of the agency consultation effort are included in
- 5 the ERR appended at Exhibit H, Tab 1, Schedule 2 at pages 32-37.
- 6 As required by the Radio Advisory Board of Canada, RES Canada has also consulted
- 7 several agencies with respect to possible interference with communications towers.
- 8 Details of these consultations are set in the ERR at page 37-38. This consultation
- 9 influenced a decision, by the Applicant, to re-locate one turbine relative to its original
- placement in the Talbot Windfarm lay-out.

1

- In November 2008, RES Canada voluntarily issued a draft ERR for public and agency
- 12 consultation. This draft was available until March 2009. A number of federal, provincial
- 13 and municipal agencies commented on the draft ERR. These comments were
- 14 addressed and included in the final ERR.
- 15 Since the release of the final ERR, RES Canada has received additional comments
- 16 from and further consulted with three agencies. None of these comments related to the
- 17 Transmission facilities of Talbot Windfarm.

18 <u>Ministry of the Environment</u>

- 19 The MOE in a letter dated May 29, 2009 required additional information with respect to:
- 20 land use and buried electrical cables:
- the location of potential cement/concrete batch plants;
- the potential need for blasting;
- RES Canada's consultation with respect to Transport Canada and NAV Canada and impact on local airfields:
- the proximity of Talbot Wind Farm to waste disposal sites;
- the need for a Stage 2 archaeological assessment; and
- the cumulative impact of Talbot Windfarm and other windfarms.
- All of the abovenoted issues were addressed by RES Canada, and the MOE on June
- 29 29, 2009 issued a letter indicating that it was satisfied with RES Canada's responses.

Ministry of Natural Resources

- 2 The MNR in a letter dated June 1, 2009 required additional information with respect to:
- the impact of Talbot Windfarm on aggregate resources;
- 4 tabulated bat study data:
- 5 the presence of turbine within a bald eagle lake access area; and
- the monitoring plan for the eastern foxsnake.
- 7 All of the abovenoted issues were addressed by RES Canada through discussions with
- 8 the MNR, a slight modification of the project design agreed upon with the MNR, and
- 9 through post-construction monitoring and mitigation to be developed in the
- 10 environmental management plan in consultation with the MNR and Environment
- 11 Canada.

Environment Canada

- 13 Environment Canada in a letter of June 12, 2009 emphasized the need for pre-
- construction and post-construction monitoring and asked to be included in the design of
- the post-construction monitoring plan.

16 <u>Federal CEAA Screening</u>

- 17 RES Canada has also applied for ecoEnergy funding for Talbot Windfarm, which
- triggers the need for a screening pursuant to the Canadian Environmental Assessment
- 19 Act ("CEAA"). The ERR was prepared in compliance with both provincial and federal
- 20 environmental assessment requirements. As the CEAA screening process was
- 21 triggered by the ecoEnergy application, Natural Resources Canada is acting as the
- 22 Responsible Authority. All federal departments and agencies have received the
- 23 coordination notice from Natural Resources Canada and will indicate whether they have
- 24 an interest in reviewing the ERR by August 4, 2009.

PUBLIC CONSULTATION - INDIVIDUAL STAKEHOLDER CONSULTATION

- 2 In order to consult with individual interested parties and landowners, RES Canada held
- 3 three "Public Information Centres" at which information was provided to the public and
- 4 individuals had an opportunity to ask questions and provide feedback.
- 5 The first Public Information Centre was held on July 21, 2007 at Morpeth Community
- 6 Hall. Landowners were advised of the Public Information Centre by mail and additional
- 7 residents were informed through advertisements in the Chatham Daily News and the
- 8 Ridgetown Independent. At this meeting, general information with respect to the project
- 9 area and the development of a wind farm was discussed.
- 10 A second Public Information Centre was held at the Ridgetown Youth Centre on March
- 27, 2008. At this meeting, the inclusion of the Talbot Windfarm Transmission Line was
- 12 announced, and two different routing corridor options were presented, one of which
- ultimately was chosen as the finalized route described in this application. At the second
- meeting, RES Canada also announced that it was voluntarily self-elevating from an
- 15 Environmental Screening to an Environmental Review.
- 16 A third Public Information Centre was held on November 4, 2008. For the third Public
- 17 Information Centre, an additional notice was posted in the Chatham Citizen. At this
- 18 meeting, more detailed information with respect to Talbot Wind Farm and the
- 19 development progress was discussed with the attendees.
- 20 At each of the Public Information Centres, representatives from RES Canada and Dillon
- 21 Consulting staff were available to answer questions from stakeholders with respect to
- the project. A number of attendees also filled out written questionnaires. The most
- 23 commonly identified issues of concern were noise and visual impact, wildlife impact,
- loss of property rights or a decrease in property value, as well as social impacts on the
- 25 location of industrial applications in a rural setting.
- 26 The comments received from individual stakeholders at the three Public Information
- 27 Centres were taken into account in the project design, primarily the siting of turbines
- 28 and the routing and placement of ancillary infrastructure, including the Transmission
- 29 facilities.

- 30 Further details regarding the individual stakeholder consultation as well as future
- 31 consultation commitments made by RES Canada are set out on pages 39-41 and 47 of
- the ERR appended at Exhibit H, Tab 1, Schedule 2.
- Following the release of the ERR, and in continuance of the future consultation
- commitments set out in the ERR, RES Canada held a fourth Public Information Centre
- was held at the Ridgetown Youth Centre on June 3, 2009. At this point, RES Canada

- 1 presented an update with respect to Talbot Windfarm, turbine placement, and the
- 2 routing of both the Collector System and Transmission System.
- 3 From the outset of consultation, RES Canada established the Talbot Windfarm Advisory
- 4 Group, which is composed of a small group of community members that include
- 5 landowners with and without turbines, city councillors, environmental groups, opponents
- and supporters. The objective of the Talbot Windfarm Advisory Group is to meet and
- 7 discuss project issues both prior to and during construction. The Talbot Windfarm
- 8 Advisory Group has met three times to date and will continue to meet until completion of
- 9 the project.
- Both before and after the public release of the ERR, RES Canada has been in constant
- 11 discussion with a number of individuals, both participating landowners and non-
- participating local residents, with respect to certain specific issues. The comments thus
- received were taken into consideration and, to the extent possible, accommodated.
- 14 Following the public release of the ERR, RES Canada has received several Elevation
- Requests, which are further described at Exhibit H, Tab 1, Schedule 1.

PUBLIC CONSULTATION - ABORIGINAL CONSULTATION

- 2 Based on its own research, as well as on feedback received from the Federal
- 3 Department of Indian and Northern Affairs and the Ontario Ministries of Energy and
- 4 Infrastructure and Aboriginal Affairs, the Applicant consulted with nine First Nations
- 5 groups and with the Association of Iroquois and Allied Indians. These consultations
- 6 commenced in late 2007.

- 7 The Applicant is continuing consultation with the four groups that expressed an interest
- 8 in participation in the consultation process. These groups are: Moravian of the Thames
- 9 First Nation, Caldwell First Nation, Six Nations of the Grand River and Walpole Island
- 10 First Nation. The Applicant has invited each of these groups to participate in the Phase
- 11 II Archaeological Study. Where necessary, the Applicant will formulate appropriate
- mitigation, approval and operation plans with affected Aboriginal communities.
- 13 A detailed description of RES Canada's aboriginal consultation up to the release of the
- 14 ERR is provided on pages 41-46 of the ERR appended at Exhibit H, Tab 1, Schedule 2.
- 15 Following the release of the ERR, no aboriginal groups responded or made any
- 16 Elevation Requests.
- Aboriginal consultation has continued following the release of ERR and is ongoing. An
- 18 updated version of the aboriginal consultation activities and the status of such
- consultation is appended at Exhibit 1, Tab 3, Schedule 2. This document constitutes an
- 20 update of the aboriginal consultation materials presented in the ERR.
