- 6. VECC requests that copies of the Application and any additional supporting materials be forwarded to each of the parties named above.
- 7. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of electricity are fully represented in the determination of just and reasonable rates for 2010. In this regard VECC intends to focus on Enersource's Hydro Mississauga Inc.'s request for rates to be effective January 1, 2010. to April 30, 2010. Issues include whether the request itself is just and reasonable and whether the appropriate adjustments have been made to the Board's 3GIRM models to accommodate this change.
- 8. VECC agrees with the Board's proposal to proceed by way of a written hearing supplemented by a technical conference and/or oral hearing to address certain specific issues, if required.

9. VECC will be requesting an award of costs for its participation in this proceeding related to the request for a January 1, 2010 effective date and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
