Re: Application for an Electricity Generation Licence Greenwich Windfarm, LP Board File Number EB-2009-0295

This letter acknowledges receipt of the above referenced application. The Board has assigned File number EB-2009-0295 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

Your application is currently incomplete and cannot be processed until the following has been filed:

- 1. Section 1, page 2 of the Application Form for an Electricity Generation Licence (the "Application Form") Name to Appear on the Licence: please provide the name to appear on the licence. The name must include the legal name of the applicant and the legal name must appear first.
- 2. Section 8, page 5 of the Application Form Facility Name and Address: the application indicates that "Greenwich Windfarm is located in the Municipality of Chatham Kent, Province of Ontario". However, the Renewable Energy Supply III Contract between RES Canada and the Ontario Power Authority ("OPA") filed with the application, indicates that the project is located in the "District of Thunder Bay near the Township of Dorion in northwestern Ontario". Please clarify this discrepancy and provide the correct facility address.
- 3. Section 9 (b), page 6 of the Application Form Other Regulatory Approvals: please provide a list of all other regulatory approvals required (e.g. environmental, municipal, etc.) Please identify the status of each approval.

- 4. Section 12, page 8 of the Application Form Finance: you have filed the applicant's pro forma income statements for 2011 and 2012 which are not signed by a key individual. This information is inadequate. Specifically, the Board requires complete pro forma financial statements including income statements, balance sheets and cash flow statements. The documents must be signed by one key individual.
- 5. Section 12, page 8 of the Application Form Finance: you have filed a copy of the Renewable Energy Supply III Contract between RES Canada and the OPA. A cover letter filed with your application states that RES Canada and the OPA are in the process of transferring the contract to the applicant. The Board requires evidence to verify this statement such as a letter signed by both RES Canada and the OPA confirming this statement along with the expected contract transfer date.
- 6. Section 15, page 11 of the Application Form Key Individual Information #2: the last question under this section has not been answered. Please re-file this page of the application form with all the questions answered. The page must be signed by the key individual.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.
