The Ontario Energy Board has now issued its Notice relating to your electricity distribution rates application. - 3) To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on Hydro One Networks Inc.'s sub transmission class customers and intervenors of record for Hydro One Networks' last distribution rates proceeding;
- 4) To file with the Board, both electronically and hard copy, an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
- 5) To make a copy of the application and evidence, and any amendments thereto, available for public review at Hydro One Networks Inc.'s website and Hydro One Networks Inc.'s offices in Toronto, Markham, Barrie, Peterborough, Sudbury, Ottawa, Dundas, Beachville, and Thunder Bay; and
- 6) To provide a copy of the application and evidence, and any amendments thereto, to anyone who requests a copy.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
