We are counsel to Rogers Cable Communications Inc. ("Rogers Cable") in respect of the above.

The Ontario Energy Board (the "Board") is initiating a consultation process regarding issues associated with the provision of service by electricity distributors and the manner in which electricity distributors apply certain charges.

Description of Rogers
