NOTICE OF APPLICATION AND NOTICE OF WRITTEN HEARING

GAS FRANCHISE APPROVAL AND APPROVAL TO ESTABLISH A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY FOR THE MUNICIPALITY OF THE TOWNSHIP OF BROOKE-ALVINSTON

Union Gas Limited (the "Applicant") has filed an application dated July 23, 2009 with the Ontario Energy Board (the "Board") under section 9 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act"). The Applicant has applied for an order of the Board approving the terms and conditions upon which and the period for which the Corporation of the Municipality of the Township of Brooke-Alvinston (the "Corporation") is, by by-law, to grant to the Applicant the right to construct and operate works for the distribution of gas and the right to extend and add to the works in the Municipality of the Township of Brooke-Alvinston (the "Municipality"). The Applicant has also applied for an order of the Board declaring and directing that the assent of the municipal electors to the by-law is not necessary.

On January 1, 2001, the former Township of Brooke and the former Village of Alvinston were amalgamated to form the Municipality of the Township of Brooke-Alvinston by Minister's Order dated March 31, 1999. The former Police Village of Inwood was administered by the former Township of Brooke.

The Applicant has applied, pursuant to section 8 of the Act, for an order of the Board cancelling the existing Certificate of Public Convenience and Necessity ("Certificate") associated with the former Township of Brooke and replacing it with a Certificate for the amalgamated Corporation of the Municipality of the Township of Brooke-Alvinston.

The Applicant currently holds franchise agreements associated with the former Township of Brooke, the former Police Village of Inwood, and the former Village of Alvinston. The Applicant currently holds a Certificate associated with the former Township of Brooke.

The application will be decided by the Manager, Licencing, who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). The Manager, Licencing does not intend to provide for an award of costs when deciding this application.

Copies of the application and pre-filed evidence will be available for public inspection at the Board's offices, the Applicant's offices, and at the office of the Corporation at the addresses indicated below.

The Board intends to proceed with the application by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board within **7 days** of the publication date of this Notice.

If you wish to participate in the written hearing, you must make a written submission that is received by the Board no later than **14 days** after the publication date of this Notice, with a copy to the Applicant, at the addresses below. If the Applicant wishes to respond to the written submissions, such response must be received by the Board no later than **21 days** after the publication date of this Notice. All submissions must be received by the Board Secretary by **4:45 p.m.** on the required dates.

All filings to the Board must quote file numbers EB-2009-0296 and EB-2009-0297, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format filed through the Board's web portal at www.errr.oeb.gov.on.ca. Filings must clearly state the sender's name, postal address and telephone number and, if available, a fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found on the "e-Filing Services" webpage of the Board's website at www.oeb.gov.on.ca. If the web portal is not available, you may e-mail your document to Boardsec@oeb.gov.on.ca. Those who do not have internet access are required to submit all filings on a CD or

diskette in PDF format, along with two paper copies. Those who cannot provide an electronic version of their filing are required to file 7 paper copies.

IF YOU DO NOT FILE A WRITTEN SUBMISSION OBJECTING TO A WRITTEN HEARING OR DO NOT PARTICIPATE IN THE HEARING BY FILING WRITTEN SUBMISSIONS IN ACCORDANCE WITH THIS NOTICE, THE BOARD MAY PROCEED WITHOUT YOUR PARTICIPATION AND YOU WILL NOT BE ENTITLED TO FURTHER NOTICE IN THIS PROCEEDING.
