AMPCO Request for Intervenor Status

Dear Ms. Walli:

I am writing pursuant to the Board's Notice of Application and Hearing dated July 21, 2009, to request that the Board grant AMPCO intervenor status in this application.

AMPCO's Interest

AMPCO is a not-for-profit consumer interest advocacy organization. AMPCO's members represent a cross-section of Ontario's major industries: forestry, chemical, mining and minerals, steel, petroleum products, cement, automotive and manufacturing and business consumers in general. AMPCO members are major investors, major employers and a major part of communities in which we operate, across Ontario.

AMPCO, and its member companies, are well known to the Board. AMPCO participates in many proceedings, working groups, consultations and initiatives of the Ontario Energy Board (OEB) in which matters of relevance to Ontario's large electricity consumers are being addressed. AMPCO works as far as possible with other industry and consumer interest organizations, both outside and within OEB proceedings. AMPCO participated as an intervenor in Enersource's 2007 Electricity Distribution Rate Change Application, Board File No. EB-2007-0706.

AMPCO's interest in the current application relates to matters that pertain generally to the interests of consumers with respect to price, adequacy, reliability and quality of electricity service. In the current application, AMPCO is specifically interested in proposals for cost increases, the allocation of those costs, the implications of declining demand and structural changes in Ontario's manufacturing sector. Any order of the Board pertaining to this application will directly and fundamentally affect major power consumers in the franchise area served by the Applicant.

Costs

I respectfully request that the Board please confirm AMPCO's eligibility for an award of costs in this matter. AMPCO has been granted intervenor cost awards in other OEB proceedings including a previous application by Enersource Hydro Mississauga Inc. The outcome of this proceeding will directly affect AMPCO members served by Enersource.



Written or Oral Hearing

Given the scope of the Application, AMPCO's preference is for an oral hearing to allow for an appropriate opportunity for discussion and examination of the Applicant's evidence.
