Your application is currently incomplete and cannot be processed until the following has been filed:

- 1. Section C12 Financial Information requires the applicant to provide information that indicates the applicant's financial state of affairs, i.e. the information provided should relate to the applicant, EnerStream Agency Services Inc., rather than the parent company, Niska GS Holdings II LP. If the applicant's financial statements are unavailable please provide one or more of the following additional information:
  - a written guarantee from the parent company; or
  - a letter of reference from the applicant's bank.
- 2. Section 8 Licensing History, question c) is not answered. Please provide an answer to this question.
- Section 10 Corporate Information, question b) requires the applicant to provide a brief description of each affiliated company's type of business. In your answer you've provided the applicant's name and type of business and not the affiliates'. Please provide description of each affiliated company's type of business.

- 4. Section D15 Personal Experience in Energy Industry, question b) regarding marketing natural gas in other jurisdictions was answered yes by key individual David Pope. The question requests that the applicant provide licence or registration type, identifier and date issued of the licensee in another jurisdiction.
- 5. Section D15 Personal Experience in Energy Industry, questions a) and b) were answered yes by key individual Charlie Barrotta referencing the same company SemCanada Energy located in Ontario.
