

Report on Notification Re: Eligibility for the Regulated Price Plan ("RPP") EB-2009-0317

Consumers eligible for the RPP will change as of November 1, 2009 as per Ontario Regulation 95/05. The consumers that will cease to be eligible for the RPP are the "designated consumers", which includes the MUSH sector.

Sioux Lookout Hydro has seventeen designated accounts that are affected by this change. All of these affected designated consumers have been contacted regarding the change by way of a letter or in person meeting.

Six of the seventeen accounts are Municipality accounts. Sioux Lookout Hydro conducted a meeting with the Municipality in December 2008 explaining the impact on electricity costs of the change from RPP to weighted average pricing. The Municipality opted to be removed from the RPP on May 1, 2009 instead of waiting until the November 1, 2009 deadline.

Three of the seventeen accounts are Hospital accounts. We received a letter from the Meno Ya Win Health Centre in June 2009 requesting to be transferred from the RPP to weighted average pricing before the November 1, 2009 deadline.

The remaining consumers were sent a letter on August 14, 2009 explaining the change. Included with this correspondence was the pamphlet issued by the IESO titled "What You Need To Know About Changes To Electricity Prices Coming November 1, 2009". See Appendix A for a copy of the letter sent by Sioux Lookout Hydro.

RE: Changes to Electricity Prices November 1, 2009

To Whom It May Concern:

This letter is to inform you of changes to your electricity prices commencing November 1, 2009. Currently your account 805121-802218 IS classified as a designated consumer and charged the RPP prices for electricity. On November 1, 2009 this account will no longer be eligible for the RPP as per Ontario Regulation 95/05 – Classes of Consumers and Determination of Rates (made under the Ontario Energy Board Act, 1998).

This means that unless you request an interval meter installed, you will be charged the weighted average electricity price, as well as the provincial benefit. If you request an interval meter, you will be charged the hourly price for electricity. Enclosed is a pamphlet released by the IESO with more information on the change.

You have the choice to opt out of the RPP at any time before November 1, 2009. If you choose to do so, please send a written request indicating that you would like to be removed from the RPP.
