Re: EB-2009-0084 – Cost of Capital Consultation

We are counsel for the School Energy Coalition. We are writing this letter to express our concern with respect to the limit placed by the Board on the hours to be spent by ratepayer groups in this consultation.

The Board's letter of July 30, 2009 sets out a limit of 12 hours per day for preparation and attendance at the stakeholder consultation. If the consultation goes the full week, that would be a total of 60 hours, of which about 35 hours would be spent in the dialogue itself, and the remaining 25 hours is available for preparation. This level is comparable to that used by the Board in other proceedings, in which it worked fairly well.

The surprisingly high volume of material filed in this matter now makes that limit problematic. With more than 800 pages of new, mostly quite dense and technically complex, material filed in September, on top of a similar volume filed in April, it does not appear to be possible even to read all the material, let alone subject it to thoughtful analysis, in the 25 hours of prep time available. This is, of course, exacerbated by the fact that the utilities are not subject to the same limit, and will undoubtedly be spending much more time than this preparing for this stakeholder conference.



Under the circumstances, we would ask the Board to consider increasing the limit on the preparation hours to a level that reflects the unexpected amount of material that has been presented to us for review and analysis.
