Huron Energy Inc. for an order approving just and
reasonable rates and other charges for electricity
distribution to be effective May 1, 2009.

PROCEDURAL ORDER No. 6

West Coast Huron Energy Inc. ("West Coast Huron" or the "Applicant") filed an application with the Ontario Energy Board, received on September 11, 2008 under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to the rates that West Coast Huron charges for electricity distribution, to be effective May 1, 2009. The Board has assigned the application File Number EB-2008-0248. The Board issued a Notice of Application and Hearing dated September 26, 2008.

On June 17, 2009, the Board issued a Decision and Order granting West Coast Huron new rates on an interim basis, and 3 months to file supplemental evidence pertaining to a post retirement benefits obligation (the "Issue"). West Coast Huron filed this additional information on September 16, 2009.

This Procedural Order sets out the steps to be followed to consider this additional information. Please be aware that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. Parties who wish information and material from the Applicant that is in addition to the supplemental evidence, and that is relevant to the hearing, shall request it by

written interrogatories filed with the Board and delivered to the Applicant on or before **Friday, September 25, 2009**. Where possible, the questions should specifically reference the supplemental evidence.

2. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Board Secretary and intervenors no later than **Friday October 2, 2009**.
3. Board staff shall file and deliver any submission on the Issue no later than **Thursday, October 8, 2009**.
4. Parties who wish to make a submission on the Issue must file that submission with the Board, and deliver it to the Applicant and all other parties no later than **Friday October 9, 2009**.
5. The Applicant's reply submission must be filed with the Board and delivered to all parties no later than **Friday, October 16, 2009**.

All filings to the Board must quote file number EB-2008-0248, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
