Re: Union Gas Limited 2010 Rates Application; Board File Number EB-2009-0275

I am writing on behalf of the Association of Power Producers of Ontario ("APPrO") to request intervenor status in the above noted proceeding and a determination from the Board that APPrO is eligible for its costs, pursuant to the Board's Practice Direction on Cost Awards.

As is well-known to the Board, APPrO is a non-profit association that represents the interests of Ontario electricity generators in a number of settings, including regulatory proceedings. APPrO members represent more than 95% of Ontario's generating capacity and are active in every generation technology: gas, wind, cogeneration, district heat and power, nuclear, hydroelectric, coal, solar, geothermal, energy from waste and fuel cells. APPrO's gas-fired generator members are major customers of the gas utilities and are directly affected by the availability of appropriate gas services and the rates that are charged for those services.

APPrO has actively participated in a number of Ontario Energy Board gas-related Proceedings including:

- (a) Natural Gas Electricity Interface Review (NGEIR) (EB-2005-0551),
- (b) Incentive Regulation Framework for Natural Gas Utilities (EB-2007-0606/0615),
- (c) Natural Gas Storage Allocation Policies process (EB-2007-0724/0725), and
- (d) the Storage and Transportation Access Rule (STAR) (EB-2008-0052).

We believe that APPrO's participation in the above has been responsible, and has brought significant specific customer and public interest value to the Board in its deliberations.

The Board has asked for opinions on whether the Hearing proceeding should be by way of a Written or Oral proceeding. APPrO's view is that in the interests of time, cost, and effort it could support a written process rather than have an oral hearing.
