NOTICE OF APPLICATION AND HEARING

ONTARIO POWER GENERATION INC. RELIABILITY MUST-RUN CONTRACT FOR THE LENNOX GENERATING STATION

Ontario Power Generation ("OPG") filed an application on August 9, 2007 with the Ontario Energy Board (the "Board") seeking approval of a reliability must-run contract ("RMR Contract") entered into with the Independent Electricity System Operator ("IESO") in relation to OPG's Lennox generating station ("Lennox"). The Application was made under section 5 of OPG's generation licence, which requires that any reliability must-run contract be approved by the Board prior to its implementation. The Board has previously approved two earlier RMR Contracts for Lennox, which is a 2,140 MW dual-fuelled (oil- and natural gas-fired) generating station located near Kingston, Ontario. The Board has assigned File Number EB-2007-0715 to the Application.

Subject to Board approval, the RMR Contract comes into effect as of October 1, 2007. Key provisions of the RMR Contract include: a term of one year without renewal or extension; payments to OPG of an estimated \$77.8 million over the contract term (comprised of OPG's fixed and variable costs for Lennox, a "margin amount" of \$1.49 million, and additional revenues equivalent to 5% of the gross revenues earned by or attributed to Lennox in the IESO-administered markets); and an obligation on OPG to offer into the IESO-administered markets the maximum amount of energy and operating reserve from Lennox in a commercially reasonable manner and in accordance with contractually stated performance standards.

In accordance with the Market Rules, the total net cost of the RMR Contract would be recovered by the IESO from wholesale market participants as part of the monthly non-hourly uplift.

Copies of the Application are available for inspection at the Board's offices in Toronto and on its website, and at the head office of Ontario Power Generation Inc. at the address noted below and on its website.

You may participate in this proceeding in one of three ways:

You may send the Board a letter of comment. Your letter should include any request to make an oral presentation to the Board, and must be received by the Board no later than 30 days from the publication date of this Notice or, if you have been served this Notice directly, no later than 30 days from the date of service.

You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than 10 days from the publication date of this Notice or, if you have been served this Notice directly, no later than 10 days from the date of service.

You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than 10 days from the publication date of this Notice or, if you have been served this Notice directly, no later than 10 days from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose

to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.

AVIS DE REQUÊTE ET D'AUDIENCE

CONCERNANT LE CONTRAT D'OBLIGATION DE SERVICE FIABLE POUR LA CENTRALE LENNOX D'ONTARIO POWER GENERATION INC.

Ontario Power Generation (ci-après, « OPG ») a déposé une requête datée du 9 août 2007 auprès de la Commission de l'énergie de l'Ontario (ci-après, la « Commission ») afin d'obtenir l'approbation d'un Contrat d'obligation de service fiable (ci-après, « Contrat OSF ») conclu avec la Société indépendante d'exploitation du réseau d'électricité (ci-après, « SIERE ») relativement à la centrale Lennox d'OPG (ci-après, « Lennox »). La requête a été présentée en application de l'article 5 du permis de production d'OPG, lequel exige que tout Contrat OSF soit approuvé par la Commission avant sa mise en oeuvre. La Commission a auparavant approuvé deux Contrats OSF pour Lennox, une centrale de 2 140 mW alimentée par deux combustibles (diesel et gaz naturel) située près de Kingston, en Ontario. La Commission a assigné à la requête le numéro EB-2007-0715.

S'il est approuvé par la Commission, le Contrat OSF entrera en vigueur le 1er octobre 2007. Les principales dispositions du Contrat OSF comprennent les suivantes : période d'un an, sans renouvellement ni prolongement; paiements à l'OPG estimés à 77,8 millions de dollars pendant la période du contrat (lesquels comprennent les coûts fixes et variables d'OPG pour Lennox, une « marge » de 1,49 million de dollars et des revenus supplémentaires qui équivalent à 5 % des revenus bruts gagnés ou attribués à Lennox dans les marchés administrés par la SIERE) et l'obligation d'OPG d'offrir aux marchés administrés par la SIERE la quantité maximale d'électricité et de réserve de fonctionnement de Lennox d'une manière raisonnable sur le plan commercial et conforme aux normes de rendement annoncées.

Conformément aux règles du marché, le coût net total du Contrat OSF serait recouvré par la SIERE auprès des participants au marché de gros à titre de charge mensuelle (non-horaire).






